Mission Statement

Introduction

Established in 1911, the FCI includes 99 Members and Contract Partners (one member per country). Each Member issues their own pedigrees and train highlyqualified judges. The FCI makes sure that the pedigrees and judges are mutually recognised by all the FCI members, Contract Partners and any person involved in their domestic canine scene.

In accordance with the celebration of the 100th Anniversary of the Fédération Cynologique Internationale, the FCI General Committee reviewed its Mission, Vision Statement and Values to maintain the Association's leadership worldwide.

In 2018, further to the decision of the FCI Extraordinary General Assembly, FCI's Mission, Vision Statements and Values were revised as follows:

Mission and Vision statement

The FCI is the highest authority of the canine culture and supports, via sits Members and Contract Partners, the well-being of pedigree dogs worldwide as well as their selective breeding and generational registrations. The FCI is responsible for safeguarding pedigree dogs' health and international pedigree dog activities to enhance the relations between dogs and humans.

The FCI recognises that the following principles and professional responsibilities are fundamental for the well-being of all pedigree dogs worldwide:

Values

- a/ The FCI considers pedigree dogs' health, temperament and behaviour of utmost importance in Breed Standards.
- b/ The FCI promotes pedigree dogs' activities and sports worldwide, which it considers beneficial for the pedigree dogs.
- c/ The FCI entrusts its commissions to make recommendations about other important matters.
- d/ The FCI divides geographically the world of pedigree dogs through its three (3) sections.
- e/ The FCI trusts its Members and Contract Partners to protect the integrity of their National Registries.
- f/ The FCI recognises and respects agreements with non-member national organisations.
- g/ The FCI sets the highest standards for its Head Office.
- h/ The FCI ensures the regular celebration of World and Section Championship events.

Im Rahmen des 100-jährigen Jubileums der Fédération Cynologique Internationale hat der FCI-Vorstand seine Mission-Statement und seine Vision-Statement sowie die Werte überarbeitet um die weltweite Führungsposition der Vereinigung in der Kynologie zu erhalten.

In 2018 wurden nach Beschluss der Außerordentlichen Generalversammlung der FCI Mission-, Vision-Statement und Werte der FCI wie folgt überarbeitet:

- d/ Die FCI unterteilt die Welt der Hunde mit Ahnentafel geographisch anhand ihrer drei (3) Sektionen.
- e/ Sie vertraut ihren Mitgliedern und Vertragspartnern, dass sie die Integrität ihrer nationalen Register schützen.
- f/ Die FCI anerkennt und respektiert Abkommen mit nationalen Hundeverbänden, die keine FCI-Mitglieder sind.
- g/ Für ihre Geschäftsstelle setzt sie höchste Maßstäbe.

EXECUTIVE DIRECTOR'S REPORT



Dear FCI Members and Contract Partners,

2019 is now well behind ... and as every second year, it was a year with a General Assembly and a huge participation of our Members despite the unusual location, Shanghai (China). We shall get back a bit further on the main decisions that were made.





Let me open my report by paying a tribute to a person who dedicated so much time to his passion: Mr Franco Mannato (FR), founder and President of the FCI Commission for Sledge Dogs. F. Mannato was the leader and steering wheel of the Commission and he was an excellent collaborator. RIP dear Franco. There may be more persons who passed away and for whom we were not notified; I apologise if I have failed to mention them!

In 2019, our Members and Contract Partners conducted a total of 1,233 international CACIB shows (vs 1,258 in 2018) and the number of dogs entered at shows for the year in review is 922,336 vs 956,554 in 2018 (as of April, 3rd, 2020). A trend towards decreasing is unfortunately observed.

However, it has to be indicated that the Section and World dog shows, depending on their location, influence the global entry statistics. Please take a look at the figures below.

Logically enough, the curve of the number of titles (beauty and work) confirmed by the FCI Head Office follows the trends of the shows: the FCI Office confirmed 9,828 (vs 10,141 in 2018) titles (beauty and work).

Our members organised a total of 2,352 trials (vs 2,279 trials in 2018) (all disciplines together) and the FCI accepted and registered 22,450 kennel names (vs 19,471 in 2018) kennel names (vs 22,580 in 2017).



What we should remember...

Cynothon: last September, the FCI Head Office organised the yearly Cynothon, for the fourth time in a row. Unfortunately, the weather was not with us but despite of that, the event was a true success.



Cinema dog day: on August 25th, following a nice FCI initiative, dogs and their owners were invited to attend cinema sessions where movies involving dogs exclusively were shown. This initiative was widely supported and appreciated.

Since October, the General Committee decided to outsource the **PR activities of the FCI**. Two co-operators were selected, Dogital Dog Services and Mr Attila Marton. The following communication platforms are extensively used: Facebook, Instagram and YouTube, on top of the institutional FCI website. We heartfully invite you to join us and express your comments. I would like to thank the former person in charge of this department, Ms Luna Durán (FCI Staff) and congratulate her on her excellent job.

Judges Directory: in September, the FCI Head Office could finally announce the launch (although partial) of the revamped FCI Judges Directory, which has now been integrated as a regular functionality in our website. We invite all our Members and Contract Partners to take an extensive look at the Users Guide (http://www.fci.be/en/ Administrator-User-s-manuals-127.html) and get back to us in case of questions. The new Directory, vs the former version, offers the visitors and users many more opportunities and functionalities. The FCI Head Office has been in contact with its legal advisers regarding the possibility to provide even more user-friendly solutions to get in touch and get familiar with the judges, still complying with the very strict EU General Data Privacy Regulations (GDPR).

Agreement between the FCI and Prof. J. Ladlow, Animal Health Trust and member of the BOAS Research Group at Cambridge Univerity: the Brachycephalic Obstructive Airway Syndrome (BOAS) has turned into an issue and the FCI could not stay passive or even worse, inactive. In this context, the FCI, through its President, Dr T. Jakkel, signed a protocol of agreement with Prof. J. Ladlow according to which the FCI will be allowed to make use of Prof. Ladlow's expertise and work in order to establish reliable diagnoses and find out the best solutions to preserve the breeding of all the breeds affected by BOAS (http://www.fci.be/en/Brachycephalic-Obstructive-Airway-Syndrome-BOAS-3502.html)

Agreement between the FCI and Royal Canin: in April 2019, the FCI and Royal Canin signed a cooperation

contract for 3 years. The FCI General Committee is delighted to associate the name of the FCI to a worldwide renown, traditional and professional Partner.









The 2019 FCI General Assembly took place in Shanghai (China) in April. A major decision was the election of a new President, *Dr T. Jakkel* (HU), former FCI Treasurer. We want to congratulate Dr Jakkel on his election and warmly thank *Mr R. de Santiago* (PR) for the 6 years he gave to the FCI as President. Later on, the General Committee appointed their vice-president and treasurer, respectively, *Mr G. Jipping* (NL) and *Mrs B. Müller (CH)*.



• Among the other important decisions made in Shanghai, let's mention the approval of the *Kennel Club de Bolivia* (Bolivia) as FCI full member and, getting promoted to the status of associated members : *Egyptian Kennel Federation* (Egypt) and the *Federata Kynologjike e Kosoves* (Kosovo). I seize the opportunity to congratulate all of them on this great achievement for their national cynology.

- In China, two breeds were recognised on a definitive basis (eligible for the CACIB and the different titles of International Champion): *Dansk-Svensk Gardshund* (Danish-Swedish Farmdog) (356) (DK-SE) and *Ciobanesc Romanesc de Bucovina* (Romanian Bucovina Shepherd) (357) (RO).
- The full members of the FCI also voted for the allocation of the **World Dog Shows** 2023 (Geneva, Switzerland) and 2024 (Kiev, Ukraine).

During the course of 2019, the General Committee approved the applications for a **contract partnership** with the following national canine organisations: Jordan Kennel Club (Jordan), **Myanmar Kennel Club** (Myanmar), **Sudanese Kennel Club Association** (Sudan) and **Federation Cynologique of Albania** (Albania). Welcome to all of them!

The FCI General Committee also approved the recognition, on a **provisional basis**, of the following breeds: *Anjing Kintamani-Bali* (Kintamani-Bali Dog) (362) (ID), *Prazsky Kyysarik* (Prague Ratter) (363) (CZ), *Chodsky Pes* (Bohemian Shepherd Dog) (364) (CZ), *Yakustkaya Laika* (Yakutian Laika) (365) (RU), *Eesti Hagijas* (Estonian Hound) (EE) (366) and *Miniature American Shepherd* (367) (USA-Patronage: HU). They are not yet eligible for the CACIB.

Last September, following some unfortunate shortcomings during the FCI European Section Show in Wels (AT), mostly due to unexpected high temperatures, the FCI General Committee adopted **a set of new provisions for the choice of countries that would host the future World and Section Shows** (application procedure, role of the official FCI Delegate).

To end up, let me express my warmest thanks to the FCI General Committee members, the FCI members, to all the presidents of the FCI commissions and to our devoted FCI Staff for their good cooperation.

FCI SCIENTIFIC COMMISSION - ACTIVITY REPORT

The Commission Meetings

The Commission held two meetings, one via internet, and another meeting as our annual meeting. The first internet meeting was held on 10.1.2019. The second, our annual meeting, was held in Lisbon, on May 17th and 18th. At this meeting, Dr Kirsi Sainio was elected as President of the Commission. A joint meeting with the Standards Commission was held on May 18th. The meetings dealt with several important issues and we made joint proposals to the FCI General Committee. Our host, The Portuguese canine organisation, Clube Português de Canicultura, has to be thanked for excellent circumstances for our meetings.

New Breeds

We sent the final proposals regarding the breed recognition procedure to the FCI General Committee, as well as proposals for the provisional or definitive recognition of breeds. The following proposal for recognition on provisional basis was accepted by the GC in the meeting in Helsinki, February 2019:

Kintamani-Bali Dog (Anjing Kintamani-Bali)

The following proposals for recognition on definitive basis were accepted by the GC after the General Assembly in Shanghai (April 2019) had accepted changes to the breed recognition procedure:

Czech Shepherd (Chodsky Pes) Prague Ratter (Prazsky Krysarik)

Inspection of these two breeds was held in Czech Republic by the Ceskomoravská Kynologická Unie (the Czech canine organisation). The inspector from the Scientific Commission was Dr Grégoire Leroy.

The Commissions recommended the provisional recognition of the following breeds, which were confirmed by the FCI GC in its meeting in November 2019:

Estonian Hound (Eesti Hagijas)

Miniature American Shepherd

Yakutian Laika (Yakutskaya Laika/Kolyma-Indigirka Laika)

Two proposals for the recognition on definitive basis of the following breeds were made to the GC, and accepted by the FCI GA in Shanghai:

Danish-Swedish Farmdog (Dansk-Svensk Gårdshund) Bucovina Shepherd (Ciobanesc Românesc de Bucovina)

Applications for recognition were discussed and recommendations for additional information were given for:

Turkish Akbash (Köpek Irklari ve Kinoloji Federasyonu) Transmontano Mastiff (Cao de Gado Transmontano; Clube Português de Canicultura) Valenciá Ratter (Perro Ratonero Valencián; Real Sociedad Canina de España)

Proposals for these breeds will be further discussed after revisions have been made.

The Commission accepted to add an old breed Rastreador Brasileiro (Confederaçao Brasileira de Cinofilia) back to the list of breeds accepted on definitive basis. The breeding programme for this old breed has been re-activated and the Brazilian canine organisation has asked to put the breed back in the list of FCI breeds.

Health Issues

1. The Brachycephalic syndrome / BOAS: follow up

The discussions on Brachycephalic Obstructive Airway Syndrome (BOAS) continued. We will follow the proceedings of this important issue.

2. HD Screening

The HD appeal procedure was revised and accepted by the FCI GA. Digitally processed x-rays are now also accepted. The meeting concerning the screening of HD x-rays in different FCI countries was decided to be held in Copenhagen in 2020 (local organiser Dansk Kennel Klub). The Scientific Advisor from our Commission is Dr Niksa Lemo.

3. Exaggerations in dogs (in general): follow up

This issue has been in the agenda of both Commissions for some time and it has been discussed on several occasions. Many FCI countries have a list of breeds where exaggerations are commonly found. The two commissions have been given a permission from the GC to proceed with this matter. Instructions given for exaggerations in any breed would be a starting point. The two Commissions will continue to work on this important subject.

Other activities:

The members of the Commission have been busy answering several questions and inquiries coming from the member canine organisations, but also from individuals that have expressed concern for a certain health, population or genetic issue in dogs. The President of the Commission participated as a speaker in the International judges education seminar held in conjunction of the Americas and the Caribbean Section Show in Acapulco, Mexico, in June. One of the organisers of this meeting was our Commission member, Dr Andrés Villalobos.

The discussions concerning dog coat colours are still very much alive, and so is the increasing interest in genetic testing in dogs. The Scientific Commission will keenly follow these issues.

The Commission still continues its work for the sake of healthy and happy dogs.

FCI STANDARDS COMMISSION - ACTIVITY REPORT

We held our annual Standards Commission meeting in Lisbon, Portugal, on Friday 17th of May 2019.

Participants in the meeting: Mr Jorge Nallem, President of the Commission Mr Rui Oliveira Dr Ferdinando Asnaghi Prof. Claude Guintard Mr Petru Muntean

Prof. Peter Friedrich could not attend due to health problems.

Election of the President: Jorge Nallem continues to be President of the Commission.



We want to thank the staff of the Portuguese canine organisation for the excellent preparation of the meeting and the welcome to all our members, all their help made our meeting much more comfortable and efficient, making it much easier for commission members.

The Standards Commission's main work continues being to revise and adapt new and existing standards. The focus on dog's health continues to have countries review the text in standards extra carefully to avoid wordings that may result in interpretations that can lead to exaggerations that might cause health risks for dogs.

The Commission continuously amends or thoroughly revises standards and the co-operation with the national canine organisations is usually efficient. Still, the procedure needs to go through several steps before a standard can be published, these documents are the backbone in the work of the FCI and its member countries.

Viewing of the text in standards from a health and welfare perspective has been intensified. This is not always the wish of the countries of origin, but is in the interest of keeping the breeds for the future; we all have to realise that exaggerations in type, as well as character issues in dogs, might not only affect the health of the dogs, it may also increase the risk to have breeds banned by law. We established a working method within the commission; how to manage the standards since they arrive to the office until they are seen and discussed by the Commission, then sent back to the country of origin, and then to the FCI General Committee for their approval before they are published.

New breeds presented for provisional recognition

Estonian Hound (Estonia), with our recommendation to be approved.

Turkish Akbash (Turkey), we think Turkey has not yet presented the necessary information of the breed to be provisionally recognized: they need to adapt the standard in the FCI Model format and make some changes.

Miniature American Shepherd (USA), with our recommendation to be approved with some changes to fit the FCI standard.

Ratonero Valenciano (Spain), not enough information to recommend for provisional recognition, they need to improve the standard.

Yakutian Laika (Russia), with our recommendation to be accepted provisionally.

Transmontano Mastiff (Portugal), some small amendments needed.

a) Chihuahueño Nr 218
b) Presa Canario Nr 346 (needs to be revised again)
c) Samoyed Nr 212
d) Jamthund Nr 42
e) Azawakh Nr 307
f) Borzoi Nr 193
g) Dachshund Nr 148

We suggest GC to adapt the standard of the Whippet to the standard of the country of origin: UK.

We suggest GC to reintroduce the Rastreador Brasileiro in FCI nomenclature.

In the joint meeting, many different items were discussed that have to do with the Scientific Commission, as for example the addition of the black colour to the standard of the Presa Canario.

It was proposed to hold our next meetings on May 16th and 17th 2020 in Milan, Italy, Dr Ferdinando Asnaghi having invited us to hold the meetings in his country.

Deadline to receive new information for the next agenda is Wednesday April 1st, 2020.



FCI AGILITY COMMISSION - ACTIVITY REPORT

About 40 years ago, the FCI started with the Agility Commission.

That time only 5 countries send delegates to the first meeting: France, Denmark, Belgium, The Netherlands and Austria. The Belgian delegate, Marietta van Herle, was elected as first President, then Switzerland and Germany followed as members and these seven countries set up the first international Agility rules.

Today 45 countries are sending their delegates; this shows that Agility is the most popular dog sport worldwide.

The **first meeting 2019** was in February in Helsinki, the Finish canine organisation was the host and our meeting was on the same date and in the same place the Finish canine organisation held its annual workshops with their confirmation judges.

I was pleased to make a short presentation about Agility "History/Purpose, Tasks and Competencies, Aims and WISHES". It was a chance given to me, to explain a little bit more about this special kind of dog sport to those who are not so involved in dog sport, but rather in breeding.

Some were astonished to hear: it is the only sport with the dog, which has its own Junior European Open event

under the roof of FCI, which is always celebrated in the middle of July, with about 450 starters (two classes Kids and Juniors) – this year for the first time divided in three classes under 12, under 15 under 19 years old. It is called OPEN event, because not only Kids/Juniors from Europe are able to start, but also from South Africa, USA, Brazil, Israel and other non-European countries and so they do.

And that is one of our aims and we work for it, that the dream will come true: to present the Agility sport to national and international sports organisations, with the aim of having Agility recognized as a sport, thereby gaining access to the electronic media and sports programmes on television, without paying for it and maybe to even become an Olympic sport.

Besides this short presentation, we had our meeting where we modified rules for the JEO and EO, selected international judges for 2020 for some of our international events, elected working groups to collect applications from the canine organisations for changes of judges' guidelines or obstacles guidelines, to present later on a draft to the national canine organisations.

In the middle of July, we had the Junior European Open 2019 in Switzerland, right to the border of Germany, in Kreuzlingen.

It is becoming increasingly difficult to find an organiser for the international youth event. It is the largest international Agility youth event worldwide. This year we had 476 participants (children / youth) from 25 different nations. That we were able to have this event in 2019, we need to thank Peter Feer, the delegate from Switzerland, who called in February last year (during our meeting) his colleague of TKAMO to ask him if Switzerland could be the host. The next day he got the ok, for which we were all very grateful.

It was a wonderful place, the sport place around the Bodensee Arena, and we had the permission to use the open hall, which was necessary especially during the opening ceremony, because of the heavy rain we had. For the kids it was fun to present their dogs in Agility, to keep friendship and make new friends, change their T-shirts from one to the other country, that's the way they have their special souvenirs.

It was the first time that we had three different age groups – under 12, under 15 and under 19 years. We think it is fairly divided. So we had 9 individual European Junior Winners, because of the age and different categories of height of the dogs, but only 3 Junior European team-winners, since in this case we do not have the differences between ages.

Agility European Open 2019 (EO) - Papendal / NL - the always-different event, but ... this year it was very special!







The meaning for "Open" doesn't stand only for the fact that all healthy dogs, which have fulfilled the sports achievements, are allowed to start at the EO, but all national canine organisations - no matter from which continent they are - can send starters. No wonder we did have 857 starters from 47 different nations in the competition. A "masterpiece", which needed to be organised very detailed and so it was. The team-leaders, the appointed judges from France, Denmark and The Netherlands got all the information early in advance from the host. Then, on Wednesday, in the week of the event, it was a nightmare.



The participants were still arriving, because the beginning of the event was planned on Thursday 7.00 a.m, starting with vet-check and training of the nations. A strong animal protection organisation asked for the cancellation of the event, due to the predicted temperatures (up to 41° Celcius were expected), because these weather forecasts allowed neither physical effort for dogs and humans, and because the EO is an outdoor event, they said there was no other alternative. But because the organising team, Marc and Linda Falk with all of their volunteers, the present veterinarians and also the judges, found a way out from that "disaster" - they worked out an alternative time schedule, by mutual agreement. Install Floodlights, set up outdoor several water points for human and dogs. All of them - for the sake of saving time - made the impossible possible in day and night work and put on top, a so-called telegram ticker, where everyone was shown the ring with their start times, and also the results and start lists were available promptly.

All participants and the team leaders were grateful, as there was a solution for all. Nobody complained about getting up so early in the morning or having the long break from noon to the afternoon, and getting back to bed well after midnight. Everyone thought of those who had to spend the night working on the PC and setting up the courses and needed to work under pressure.

Thanks to all, who helped to run the EO in such a wonderful atmosphere. All participants were happy and we had excellent results:

September 2019 again we were invited to Finland, where we had our FCI World Championship in Turku





At this World Championships, the term aliens was used as a synonym for the German team, not from the German fans, but delegates from other nations did think so and communicated it that way, because the Germans have been successful also over the last years.

The Agility World Championships in Turku was very well prepared and really scored points with the Gatorade Center, a multifunctional hall in the Finish city of Turku. This hall was perfect for the FCI Agility World Championship.

The Finish Agility Association did work closely with official sport departments and have been well known there for years, where Agility is also recognised as sport. This automatically results in benefits that unfortunately do not exist in the other nations.

Public and local television were present on all days of the event, recording all the runs, interviewing the winners, reporting on local television on all the days of the event

and a summary of 2 hours of "highlights" on Saturday night prime time. You need to know the fact that there was the Livestream, Youtube and Facebook in addition. So, if you want and didn't do before, you can get a bit live atmosphere via: https://youtu.be/SGfKjToIJjE and see a lot of top starters with their excellent runs.

There are reasons that the German starters worldwide are feared as very serious competitors. Just the last few years have shown how consistently they have established themselves in the world class. But they have never been as successful as they have been this year:

At the World Championship, we had a doping control by drawing, where one of the German team members was controlled. In Germany, we are used to it, because we do the same. No one knows, when and where (which event) is selected to be controlled. All three hosts of our international events with all their volunteers, my colleagues, who have been supervisor or have been measuring judges did an excellent job. I would like to thank them all.

Monday following the WAC, it is obligatory to hold the second meeting of the Commission, this time the agenda showed elections of the board members and election of the judges for next year's FCI Agility World Championship in Estonia, and determination of an international Judges' workshop in Russia. All board members were reelected and all members of the Executive Board of our Commission keep the same responsibilities.

Last but not least, I would like to thank the Executive Director and the employees of the FCI office for their good cooperation and work. But a real warm thank to the new elected FCI Executive board, who confirmed our application to change the name of the Junior European Open into Junior Open Agility World Championship (JO WAC). So, from 2020 onwards, we will have the first World Championship for kids and juniors under the roof of the FCI.

FCI BREEDING COMMISSION - ACTIVITY REPORT



FCI Breeding Commission's (BC) annual meeting was held in Tallinn on 18th May 2019, at ParkInn by Radisson Meriton Conference and SPA Hotel.

At the start of the meeting the FCI Representative, Carla Molinari, intruduced herself and stated that her

goal in participating in the Breeding Commission (BC) meeting is to ensure BC prepares viable proposals, that are directly related to Breeding (and not to areas that are best addressed by Scientific Commission, Standards Commission or other).

Election of the President, Vice-president and Secretary of the Commission for the next two years.

Janne Orro is elected President of the FCI Breeding Commission, Nikola Smolic – Vice-president and Inga Cerbule - Secretary

White Swiss Shepherd dogs

FCI Circulars 77/2007 and 32/2013. White Swiss Shepherd Dogs should not interbred with white German Shepherds. Yet dogs are imported from the US and Canada that have German Shepherds in their immediate ancestry (within 3 generations), and in several countries these imported dogs are allowed to interbreed with White Swiss Shepherds, and resulting offspring are recorded in national organisations' Studbooks. It is unclear how many dogs are handled like this and how wide this problem really is. Nevertheless, if NCOs are acting according to valid FCI Circulars 77/2007 and 32/2013, this problem resolves. *BC proposal: FCI could send a reminder to NCOs about Circulars 77/2007 and 32/2013 and advise NCOs to register White Swiss Shepherds having German Shepherds in 3 first generations in their pedigrees in the Appendix.*

The Brachycephalic Syndrome (BOAS)

This issue causes a lot of tension in the public sphere, and also heated discussion. It is widely recognised that representatives of several dog breeds that have shortened muzzles may suffer from a complex of symptoms characterised by restricted airflow when breathing, which may lead to overheating, exercise intolerance, snoring, suffocating, a poor quality of life, and may even require surgical intervention to restore airflow. Sweden has been proactive in dealing with the BOAS issue and has a number of programmes that aim to improve the state of health of these affected breeds. This subject has raised a controversy: Should FCI as guardians of pedigree dogs follow the recommendations of the veterinary profession and animal welfare / animal rights organisations, and select for different (longer) head proportions in the brachycephalic breeds? Or should FCI hold firm to our Breed Standards and tradition? Canine organisations need to ensure that brachycephalic breeds are bred as healthy as possible, as there is a lot of tension about this in mass media. FCI has influence, and with influence comes responsibility. If we do not work together we may lose our right to keep and breed purebred dogs.

The Swedish and Finnish canine organisations have presented documents on wide-ranging initiatives their kennel clubs are taking to improve understanding and to breed healthier dogs, such as seminars for breeders and for veterinarians, specific requirements for show judges, requirements to report surgery and C-sections to national canine organisations, which would then make sure the dog is not used for breeding. This includes close co-operation among Nordic Kennel Clubs. The question remains, however, what can FCI do to help ALL dogs with this problem, whether they are in the FCI system or not, pedigree dogs or not. How do we reach non-FCI dogs of these breeds that are also suffering? Do EU Privacy and Data Protection laws allow us to find and contact the owners of young dogs that may be at risk? How can the pet-buying public be better educated to understand that wheezing and shortness of breath is not cute, but rather symptoms of a problem? BC had rather long discussion on these subjects. There are no proposals from BC. BC cannot ignore this issue in future if this subject is proposed to our agenda. BC feels that close cooperation with the Scientific and the Education & Public Relations Commissions is needed. BC is interested to gather information about breeding programmes and other measures that are taken in NCOs in order to breed healthier dogs and raise awareness in general public, as well as show the important role of NCOs in keeping purebred dogs.

Reminder that all National Organisations must follow the FCI Breeding Rules and Standing Orders

Pedigrees issued by unrecognised organisations should not be accepted as FCI pedigrees. Dogs with pedigrees by unrecognised organisations should be entered in the Appendix, with empty pedigree, that is, with no ancestors recorded. Each NCO can work out a procedure how to accept these dogs into the Appendix. In most countries, this process is already in place and functioning. If NCOs come across any non-recognised pedigrees that have been fully (incorrectly) accepted as FCI pedigrees, then these pedigrees should be forwarded to the FCI.

The Breeding Commission decided to drop the issue, as there is already a procedure in place. Such pedigrees may be sent directly to the FCI Head Office, we would like to know if they have received any such pedigrees before, and what action was taken.

Nomenclature of coat colours

There is a need for a standardised nomenclature of coat colours, as it is required to write coat colour in pedigrees. There are manyfold issues regarding coat colour:

- a) there is an accepted nomenclature of coat colours that is used in genetics, but breed standards often use a different, traditional nomenclature, that may or may not be scientifically correct. These terms are traditional in each breed, and cannot simply be discarded,
- b) a colour that is genetically the same across different breeds may be called different names in different breed standards,
- c) the same colour term may or may not be easily and precisely translated from language to language,
- d) then there is the question of breeds that allow many colours, or any colour. The issue is that colour names should not just be invented, there should be a glossary that is used the same way by all NCOs.

A way to work with this problem was demonstrated by Ms Roest: Raad van Beheer has created a database with a list of acceptable colour names for each breed.





In breeds that accept many coat colours, or all colours, the number of listed colours is limited to 25. When registering a dog, only colours that are on this list may be used.

There is a suggestion that in breed standards the traditional colour nomenclature can continue to be used, while adding the scientifically accurate term for this colour, between bracket parentheses.

Some BC members volunteered to create a working group to develop such a coat colour list by their respective FCI Groups just to begin with work.

Proposal: Coat colour on FCI Export pedigrees has to be recorded in one of the four FCI working languages: French, English, German, Spanish. BC stresses the need for a transition period.

HD screening results seem to be worse in Scandinavia: are the requirements harder?

Scandinavian NCOs have a long tradition of co-operation and information sharing in the areas of dog health and preventive testing. It is unlikely that dog health is worse in Scandinavia; testing and sharing of information are rather more extensive.

A discussion follows about different ways of utilising HD and ED screening test results. No action is needed from BC on this issue.

Registering FCI litters in a country different from the country of birth

In Europe, with its open borders, it is common for people to travel, change residences across borders, and to have legal residence in one country while living in another.

Registering a litter in a country different from country of birth may also be done for fraudulent reasons, such as to avoid breeding restrictions or circumvent a limit on the frequency of litters. The FCI General Committee feels that every NCO should follow their established rules and report to the FCI if there are problems.

The European Section has discussed the subject at length and came to the conclusion that registration in a different country may be allowed if NCOs of both countries agree.

The new Article 20.1 of FCI Standing Orders states:

For a dog to be eligible for entry in a studbook or appendix, it must be registered by the Member / Contract Partner of the country where its owner has legal residence.

A litter must be registered with the Member or Contract Partner of the country where its breeder has legal residence and the litter was born. Exceptions may be made by mutual agreement between the Members or Contract Partners involved. Proposal: Include this text into FCI Breeding Rules.

Art 18

A litter must be registered with the Member or Contract Partner of the country where its breeder has his legal residence and the litter was born. Exceptions can be made by mutual agreement between the Members or Contract Partners involved.

Recognition of a ridgeless variant of the Ridgeback breeds: Rhodesian Ridgeback and Thai Ridgeback

The reasoning is that ridgeless puppies are more or less unavoidably being produced, and using them for breeding may lower the incidence of Dermoid Sinus, that was thought to be associated with having a ridge. By recognising the variety, the breeders have a bigger population to select from. Since they are born, it is a logical step to allow them to be judged, therefore it's possible to get a better view of the progeny of certain breeding animals.

BC was contacted by KUSA and several RR Breed Clubs, including the Rhodesian Ridgeback World congress (RRWC), and a letter signed by breed clubs of 22 FCI countries, against recognising the Ridgeless variety of the Ridgeback breeds. Current research does not provide direct scientific proof of a causal link between the presence of a ridge and incidence of Dermoid Sinus. The rates of Dermoid Sinus now stand at 1.7% worldwide.

A similar result was presented from the Rhodesian Ridgeback Club in Denmark, stating that incidence of Dermoid Sinus has decreased from 5.3% in 2006 to 1.7% in 2015, across 20000 puppies, born in different countries.

As the incidence of Dermoid Sinus wordwide is small and decreasing, and no scientific proof has yet been found that presence of the ridge causes Dermoid Sinus, there may be no need to recognise the Ridgeless variety of the Ridgeback breeds.

Decision: The issue was forwarded to the Scientific Commission a couple of years ago, and is no longer an issue for futher discussion in the Breeding Commission.

Joint meetings between BC, Show Judges Commission and Show Commission

After the FCI General Committee meeting of November 7th, 2018, the GC issued a statement: The GC sees no need for a joint meeting with both, Show and Show Judges Commissions, at the moment. The FCI Representative, Mrs Molinari, stresses that BC should respect the GC decision and not try to make a revolution.

Ms Volarikova states that a joint meeting may be possible in Prague in 2022.

Decision: In light of the new leadership of the FCI, BC is free to ask the same question again and continue seeking a joint meeting.

Breeding for longevity

A presentation by Pernille Monberg, breeder of Irish Wolfhounds, will be published on the FCI website.

Decision: Ask for update, when the material will appear on FCI website.

Artificial insemination, ownership of frozen semen and autorised storage

International Breeding Rules of the FCI chapter Artificial Insemination has been discussed in BC earlier meetings. BC makes a proposal to add additional text to this chapter.

Proposed extra text:

The stud dog itself, as well as its sperm, are both legally seen as a property. When collecting semen for processing, the ownership of the semen needs to be specified by a written document. The document should also state the date of collection, the doses of sperm, identification of the doses, place of storage and identification of the stud dog.

It is strongly advised to make a DNA profile from every dog of which semen is stored.

When the stud dog is sold, or when the dog's breeding rights are transferred, the dog owner must provide the information about the already-collected frozen semen to the other party.

The semen itself may be the subject of a selling contract, or it may be sold together with the stud dog. The precise arrangements should be contracted between the parties.

The semen can only be used if the national rules for mating are fulfilled, especially securing that the semen may only be used for bitches registered in the FCIrecognised studbooks.

The owner of the semen is entitled to sign a stud service certificate. The owner of the semen must provide the information about the date of semen collection, identification of the doses, place of storage and identification of the stud dog.

FCI registered kennel names

What happens to kennel names when the owners are deceased, how long will FCI keep protecting the kennel name? It is unacceptable that famous kennel names can, in theory, be used by other persons that may have nothing to do with the original breeder and original bloodlines.

Proposal: Removed FCI kennel names must be blocked so that they cannot be used by a different person, except as described in Article 9 of Breeding Rules, stating that NCO may choose to assign a kennel name to a breeder's successsor.

Proposal to change FCI Standing Orders Article 21 – Kennel Names

Existing text: a) Dogs cannot bear in their registered name, as prefix or suffix, a kennel name other than one of their breeders. Deemed to the breeder is the owner of the bitch at the time of the birth of the puppies.

Proposed text: a) Dogs cannot bear in their registered name, as prefix or suffix, a kennel name other than one of their breeders unless written agreement between involved parties is presented upon registration of litter. Deemed to the breeder is the owner of the bitch at the time of the birth of the puppies.

Update on Breeding for Function

Most modern dogs are companions, and no longer perform their original function. Breeding for function means not only physical and mental exercise, but also physical and mental health. **Presentation by Maria Cecarelli planned for 2020.**

Inverted canines

Presentation on inverted canines and the possible hereditary background, as well as prevention.

Presentation by Dr Janne Orro planned for 2020. BC will also contact Dr György Tesics (Hungary) to present the topic.

International Breeding Rules

Ms Idrebo proposed changes to the International Breeding Rules. Proposals were discussed in the meeting and the proposed text was amended.

Proposal: Article 1. FCI International Breeding rules

Point 3:

Only functionally and clinically healthy dogs, with breed typical conformation, should be used for breeding; i.e. to only use dogs that do not suffer from any serious inherited disease or functional disabilities. Dogs with eliminating faults such as e.g., but not limited to, unsound temperament, congenital or inherited deafness or blindness, cleft palate, substantial dental defects or jaw anomalies, PRA, epilepsy, cryptorchidism, monorchidism, albinism, improper coat colours or diagnosed severe hip or elbow dysplasia or diagnosed as severe of other screening tests on hereditary diseases, may not be bred.

New point 4:

It is not beneficial for healthy dog population to rule out too many dogs from breeding; the goal is healthy offspring. Results from DNA tests for inherited diseases should be used to avoid breeding diseased dogs. Dogs shown to be carriers of a monogenic recessively inherited severe disease should only be bred to a dog that is proven not to carry the allele for the same disease.

Point 5 (old point 4)

With regard to surfacing hereditary defects, such as but not limited to hip or PRA elbow dysplasia or inherited eye diseases, the FCI member countries and contract partners are obliged to record affected animals, combat these defects in a methodical manner, continuously record their development and report to the FCI on this matter when requested. If a DNA test is performed, the identification (chip or tattoo) of the dog must be checked and certified by the veterinarian who collects the sample as in the case of any other health protocol;



the test result certificate from the laboratory must include the dog's identification.

Intruduction to Estonian Hound

A breed in active process to FCI recognition, by Dr Janne Orro. A video on the breed, its history and charecteristics is presented.

Time and place of next meeting

Moscow, May 30th, 2020 Italy, city and date to be announced, 2021 2022 – Czech Republic

Dogs with incorrect colour, such as particolour Poodles, white Boxers, etc.

Dogs with incorrect colour, such as Particolour Poodles, White Boxers, mating with American-Pedigree dogs (ancestors with incorrect colours), how to handle these issues. While the countries of origin of a breed do not accept these colours, and they are often a disqualifying fault, in other NCOs these dogs are being shown and given good evaluations (Excellent). If an imported dog itself is of a colour that is correct according to the Breed Standard, and its Pedigree lists ancestors that have improper colour, then no action is required.

Proposal: BC advises to recognise the AKC pedigree if the dog itself is correct colour, regardless the incorrect colour of the ancestors. If any offspring of this imported dog are incorrect colour, the offspring can receive Limited registration.

Name tags for BC delegates

Ms Cerbule recommends that, on future meetings, delegates are issued name tags, so new delegates can get to know people and freely engage in discussion.

Decision: Issue name tags at further meetings, to be organised by host.

On March 17th 2019, in Nis (Serbia), the FCI Commission for British Pointers - kindly hosted by the Serbian Kennel Club - had its annual meeting to discuss the topics on the agenda:

- 1. President's report
- 2. Minutes of the last meeting in France on 28.3.2018
- 3. 2019 European Cup organised by Belgium in Serbia on 18/19.3.2019
- 4. 2020 European Cup
- 5./6. European Cup Regulations
- 7. Miscellaneous

With great satisfaction, we must point out the collaborative and constructive spirit that emerged during the entire duration of the meeting. A lively debate, aimed at the enhancement of the British pointing dog, always respecting the provisions of the FCI, has led to a substantial formulation of proposals, primarily with a view to bring order to the state-of-the-art and immediately afterwards, to project towards the future of a world that, rich in tradition, history and culture, remains today more relevant than ever.

Decision of the FCI General Committee: Approval

B) to ask the FCI Head Office to write to all countries to encourage them to follow the FCI regulations, in order to have a uniform system.

Comment by the FCI Head Office: The regulations will be adjusted in the 4 languages and uploaded as soon as possible; enforcement: 1st January 2020.

Point 9 Regulations for FCI Dog Shows, page 3, 2 APPLICATIONS

Applications to get a CACIB International Dog Show sanctioned by the FCI must be sent to the General Secretariat of the FCI latest 12 months before the show or earliest four calendar years before the show. Decision by the Commission:

This time can be altered in justified cases accepted by the FCI Head Office. (The FCI Head Office got the allowance to shorten the time if necessary).

Decision of the FCI General Committee: Approval.

"This timeframe can be altered in justified cases accepted by the FCI Head Office".

The great Show highlights of the year in the different continents

The World Dog Show in Shanghai, China, 2-3 May, the European Section Show 14-16 June in Wels, Austria, the Asia, Africa and Oceania Section Show in Ilsan, Republic of Korea, 16th June and the Americas and the Caribbean Section Show in Acapulco, Mexico, 23rd June achieved a big number of exhibited dogs.

All BIS dogs were able to reflect the international flair of these important exhibitions.











In total, 1233 CACIB shows where organised in 2019, which is - compared to the previous year - 27 CACIB shows less. This number is divided into 831 (+35) shows in the European Section, 198 (-9) in the Section The Americas and the Caribbean and the Asian Section. The Africa and Oceania Section organised in total 204 (-53) CACIB Shows.

This number reflects only the CACIB shows and it would be very interesting to get to know how many national shows for all breeds are organised in the different countries and continents

As this is my last annual report in this Commission, I would like to thank all delegates most warmly for their always highly productive cooperation.

FCI OBEDIENCE COMMISSION - ACTIVITY REPORT

Annual meeting

The FCI Obedience Commission had its annual meeting 2019 in Kladno (Czech Republic), after our Obedience World Championship, on 7-8 June. Combining the competition and our annual meeting turned out to be a good solution. It is especially convenient for those from far-away countries to be able to attend both the competition and the meeting. Thus, we had altogether 20 representatives attending the meeting. We were happy to welcome the representatives of Bulgaria, Japan, Slovenia and Ukraine. These nations were represented for the first time in the Obedience Commission. Hosting both the competition arrangements and our annual meeting is a lot of work. We all wish to thank Mrs Vilemina Kracikova, representative of the Czech Republic, for her huge input and for successfully hosting both the competition and meeting.

Revising the rules for Obedience trials and competitions effective from 2021

The Commission finalised the rules for obedience trials and competitions for Classes 1 & 2 & 3. The novice class is up to each nation to plan the exercises and rules and regulations. A good aim for the novice class is, on the one hand, to get the handlers interested in the Obedience sport and, on the other hand, to plan suitable exercises to build up for the exercises of the following classes. It was decided to apply a more lenient judging in the lower classes and also to adjust some small details in the higher class, which could also be described as applying more leniency. Some slight changes were made in a few exercises and class 1 was made a bit shorter, with less exercises. The new rules and regulations were approved by the FCI General Committee. There were some pleased comments on the changes and so the Commission hopes to have more competitors and more countries applying these FCI rules.

Revising the rules for World Winner Competitions in Obedience effective from 2021

The rules and guidelines for the World Winner / Obedience World Championship were finalised; they will be sent to the FCI General Committee for approval. The number of teams has been increasing and it is not unusual to have teams from 20 countries. Thus, the layout for the competition had to be changed so that this will be possible. The layout today cannot allow more than 100 teams. The new layout enables up to 150 teams. The increased interest to participate in OWC competitions promoted some changes in the layout of the competition.

As the World Winner Competition in Obedience is not tied to the World Winner Dog Show anymore, the Commission plans and decides on the sites of future World Championship competitions some 4-5 years ahead, and appoints the judges for the WW competitions.

Obedience Champion Titles

A constant topic for discussion at the Commission meetings seems to be the Obedience Champion titles. Unfortunately, some countries do not have this title yet, so we wish to promote this. Also, another goal is to make it possible for a champion of its own country to become a champion of another country, with one excellent in class 3. As this is a sport with qualitative judging, the "excellent" means that the dog has reached a certain level of Obedience and thus winning should not be necessary.

World Winner competition 2019

The World Winner competition 2019 in Obedience was arranged in Kladno (Czech Republic) on 4-7 June. It was an outdoors competition at the Sletiste sport center. Accommodation facilities were at walking distance, which was an advantage for the staff. Many of the competitors could be accommodated nearby as well. Altogether 112 competitors from 20 countries enrolled.

The judges of the competition were: chief judge Mr Uwe Wehner from Germany, Miss Svetlana Zolotnikova from Estonia, Mr Mats Möller from Denmark, Mr Lukas Jansky from Czech Republic and Mr Hanspeter Jutzi from Switzerland.

There were some changes in the team results. Sweden won the gold medal, having been second last year and having been away from the top three for a few years before that. Norway kept its silver place from last year and Russia was third, having climbed up steadily for several years. Spain made a huge input and was placed fourth, with three teams in the finals. Finland was fifth. This was a disappointing drop, but maybe an anticipated one, from having won the gold medal for many years in a row. And Austria was sixth.

In the individual, representatives from Sweden were highly placed: Gold, bronze and sixth place. Spain has had a wonderful Labrador retriever in the finals for many years. This time, Jesús Martin and Tyson made a very impressive work and were placed second in the finals. They had a strong grip of the golden medal for a long time, but the last dog made an even better score and thus won a well-earned gold medal.

Traditionally, the President of the Commission gives out one to three special prices. This year one was received by Janine Metzler (CH) and her Malinois Azuka-Akylah vom Buxtehuder Bullen from Switzerland, and the other by Maarit Hellman and her Border collie Stjerne from Finland.

FCI COMMISSION FOR RESCUE DOGS - ACTIVITY REPORT

As planned during the setting up of the new FCI Rescue Dog Commission board, we focused our efforts for 2019 on four points:

- 1- update of FCI-IRO regulations
- 2- strengthening of our partnership with IRO
- 3- visibility of our activities within the FCI
- 4- FCI Rescue Dog Commission Seminar

1 - Update of FCI-IRO regulations

FCI Rescue Dog Commission meeting on 23 and 24 February 2019 in Sollentuna Sweden:



First of all, we have to thank again the Swedish canine organisation a thousand times for its tremendous welcome at the headquarters of their association. In a word, it was simply great!

At this meeting we reviewed and updated all FCI-IRO rules and the new specifications for the FCI Individual Rescue Dog World Championships, which will be held for the first time in Italy in 2021. All these proposals have been accepted by the FCI General Committee.

Thanks to the invaluable help of Catherine Gomrée of the FCI General Secretariat without which it would not have been possible to publish all of these updated regulations on the FCI website in June 2019. It should be noted that henceforth our Commission has 24 different nations compared to 19 in 2018, namely: Bulgaria, Spain, Philippines, Poland and Ukraine.

2 - Strengthening of our partnership with IRO



We have further strengthened our collaboration with our IRO partner by working together on the implementation of the new IRO / FCI Regulation, by creating an annex to it to better explain its implementation and answer the many questions from users.

In addition, we accepted their invitation to attend the various ceremonies of their twenty-fifth World Championship, which took place in September 2019 in Villejust, in the vicinity of Paris, France.

We highlighted this twenty-fifth World Championship by offering a trophy to the first of each discipline.

3- Visibility of our activities within the FCI





We are currently working on establishing a better visibility of our activities in collaboration with the FCI Secretariat and we are doing everything possible to highlight the discipline of rescue dogs.

It is for this purpose that the French Leonberger Club came to volunteer for a demonstration of water rescue at the FCI Cynothon in Montigny-le-Tilleul, on September 29th, 2019.

Our French friends travelled more than 1500 km round trip for this event! It was a real success! Thank you Michèle Esperonnier and Xavier Remy!

Thanks also to Mrs Marie Luna Durán, of the FCI General Secretariat, for her dedication to this cause.

4- FCI Rescue Dog Commission Seminar

The board of the Rescue Dog Commission has decided that, in the future, the judges' seminar will be replaced by the Rescue Dog Commission seminar where not only the judges, candidate judges are invited, but also the competition organisers and coaches. We believe that everyone should be clearly informed of the new guidelines. This year, we were wonderfully received by the Slovenian canine organisation in the city of Kranj. Thanks to our Vice-president and Slovenian delegate, Mr Marko Brucan, for the work done.

Nearly 30 people from 16 different nations participated in this seminar which was divided into three distinct parts:

1-the presentation of the new regulations and specifications for the next World Team Championships to be held in Romania in 2020.

Speakers: Mrs Daniela Erasmus (AT), Mr Liviu Ionescu (RO), Mr Marko Brucan (SI), Mr José Buggenhout (BE).

2- the presentation, in theory and in practice, of the new discipline of "Man trailing".

Speakers: Mr Matjaz Zanut (SI) , Mr José Buggenhout (BE).

3- answers to questions previously asked by users of rescue dogs via their respective delegate.

Presenting suggestions for improving our rules to the FCI Working Group to take this into account in legislating on this issue with the IRO Working Group. Speaker: Mrs Daniela Erasmus (AT).

> We will publish as soon as possible these presentations on the FCI website. It was a wonderful meeting during which everyone was able to express themselves freely, it was the goal in fact.

> We hope that all the efforts made in 2019 will bear fruit in the future, that we can already foresee serenely.

FCI COMMISSION FOR RETRIEVERS – ANNUAL REPORT

The FCI Committee annual meeting took place in Tudela (Spain) on December 6th, prior to the ICC. Stefano Martinoli from Italy and Andrea Böszörményi from Hungary were confirmed, respectively, President and Vice-president. The Commission appointed Anja Moller (Germany) as Secretary, succeeding to Paulina Ahola (Finland), who the Commission warmly thanks for the great job done in the last few years.

The Commission discussed about a review of the international regulations for Field Trial and the IWT and agreed to investigate further the various aspects in the next few months.

IWT 2019

The IWT 2019 took place in The Netherlands on June 1st and 2nd. The tests were held on a beautiful estate around the manor-house 't Zelle. The old woods provided lots of shade for dogs and humans to keep cool during an unusual warm weekend. The organisation was in the hands of the Dutch Retriever Club (Nederlandse Retriever Club), which did an excellent job.

40 teams from 12 different Countries took part in the event.

For the first time in history, a team from the UK, Scotland, took part in the IWT and...eventually...won it!

Under the experienced guidance of Captain Roddy Forbes and his Glenpatrick Mica of Carnochway, Georg Buchan with Misty Longa and David Lisset with FTCH Buccleuch Xena summed up a total of 517 points over the two days, 4 more than Finland's National Team 3, captained by Maarit Nikkanen. Italy National Team 1, captained by Salvatore Zappavigna completed the podium after an amazing comeback on the second day.

The IWT 2019 was fairly judged by Mrs Philippa Williams (UK), Mr Billy Steel (UK), Mr Pieter Vijvis (Belgium), Mr Frank Hermansen (Norway) and Mr Roy Ehbel (The Netherlands).

During the prize ceremony it was announced that the 2020 IWT would take place in Austria.

ICC 2019

The ICC 2019 took place in Tudela (Spain) on December 7th and 8th. The judges were: Mr Paul Toal from Ireland, Mr Bobby Robertson from England, Mr Jo Serruys from Belgium and Mr Stefano Martinoli from Italy.

34 dogs entered the competition representing 9 countries.

The grounds where the trial took place were quite unusual for many competitors, and many dogs had to deal with small quails, which were quite difficult to retrieve. However, the high standard quality of dogs and handlers allowed 19 competitors to finish the first day with three clean retrieves and move on to the second day.

On day 2, 8 dogs remained in contention after the 4th and 5th retrieves. Among them, the best performance was provided by a young man from Spain, Adrian Sifre Flores, at his very first experience in the ICC, with his 3-years old black Labrador Crack de Enanzo bred by Ignacio Ariza.

For the second year in a row Pieter Vivijs from Belgium got the res Cac, res Cacit, this time running a female Golden Fetriever, Think Twice Uh la la la. The third place was awarded to Marin Incedì, from the Czech republic, with FTCh Arapaho Shelf Lavondyss.

Six more dogs finished the trial with a qualification of very good or good. During the presentation it was announced that in 2020 the European Championship would be held in France.

FCI SHOW JUDGES COMMISSION - ACTIVITY REPORT

Bogota meeting 2019

ACCC (Asociacion Club Canino Colombiano) was the host of our annual meeting, held in Bogotá, Colombia. On February 2nd was our meeting with 20 delegates from countries coming from all FCI Sections. The meeting was at Hotel NH Collection Bogotá Teleport, everything was very well set and organised perfectly. We had two intense days of work but also time to visit some emblematic places of the city such as the gold museum, the old Bogotá, and on Sunday night enjoyed a very fun farewell dinner. We congratulate and thank our hosts ACCC President Mr Luis Alberto Martin Leudo, Aida Rivero and Juan Alberto Grillo for the perfect job and to give all of us a memorable and very pleasant stay.

Our work and discussion often led to several proposals for the FCI Board.

FCI judge's directory

A new FCI judges Directory section is already added to the FCI website. This directory includes not only all FCI Show judges, but also working dog judges, Agility judges, etc. As FCI must follow the "General Data Protection Regulation" of European Union, it's not possible to publish the complete information of each judge. We remind all national canine organisations (NCO) to send the updated list of their judges to the FCI office, also to take into consideration that a specific form must be filled for each new All-Breed judge.

The FCI office is monitoring and reviewing the lists of current judges, requesting in several cases additional information to validate them.

Breed-by-breed education

Although many efforts have been made, unfortunately only few breeds are already published. These represents 6% of the total FCI-recognised breeds. We will continue trying to convince our organisations of the importance of having a presentation, video, or detailed report, developed by the country of origin of the breed. The FCI office sent a new circular to every NCO to remind them of the utmost importance to have this information available for exhibitors, breeders and judges.

Basic education programme

A task group has been working on it, the Conclusions and proposals were presented in Bogota. Mr John Wauben, on behalf of the group did, the presentation of the "Basic Education Programme". The assembly was very satisfied with the presentation and delegated to the working group the task of polishing details and preparing a final version of the course, which will be presented for approval at our next 2020 meeting.

FCI World Judges congress

A very international audience, with 280 participants of 28 countries took place in Acapulco on 24th and 25th May for the 2nd FCI World Judges congress. The respected speakers were President Dr Tamas Jakkel, Dr José Luis Payro, Mrs Barbara Müller, Dr Claude Guinthard, Dr Bernard Denis, Dr Kirsi Saino, Dr Darko Brobnjak, Mr Jean Paul Kerihuel, Mr Petru Muntean, Mr Jorge Nallem, Mr Miguel Ángel Martínez, Mrs Peggy Gutiérrez, Dr José Luis Vasconcellos and Mr Adrián Landarte.

In a very comfortable auditorium, with an efficient simultaneous translation and perfect organization, the congress was a great success. The entire congress was filmed, and it is available on the internet in Spanish and English.

A typical Mexican farewell party was offered by the FCM for all participants.

The third world congress would be in 2021, although there were some applicants, it was decided to wait for the final decision of the Czech Republic, since it is considered that if it were organised jointly with a World or Section show it could have a greater call.

Other topics

Noting that several judges do not follow an orderly and clear procedure in the ring. We agreed to develop a manual of "Judges techniques" for consideration at the next meeting in Mallorca. The Board, with the help of some of the members, will work on it.

- We had an open discussion about Judges behaviour in social media. We agreed that there is much to do and say about this topic and that it is not easy to find a conclusion in the meeting. We voted a working group to suggest guidelines to be approved in our next meeting.
- We also addressed several other points of the regulation regarding the behaviour of judges, criteria in different countries for the appointment of judges, minimum requirements for all-rounders etc.

Joint meeting

Like every year, we also organised a joint meeting with the Show Commission. The meeting was on February 3rd, during which we talked about topics that involve both Commissions.

- *We discussed some points like: English Kennel Club rules for FCI judges compared to FCI rules for KC Judges.
- *We decided that it would be important to implement the use of the ramp when judging English Bulldogs and Basset Hounds.
- *We considered to have a link to a database, on the FCI website for instance, for International Champions and winners of Section and World shows.

Thomas Uneholt, from Sweden, did an excellent and complete presentation of "Dog shows in Sweden, survey results".

Before ending the meeting, the ACCC made a complete presentation of their national breed "Sabueso fino colombiano", not yet recognised by the FCI.

Mrs Class, M. Pichard and M. Landarte also met in Geneva in November to discuss some points and start preparing the agenda for the 2020 meeting.

We thank Yves De Clercq and his colleagues from the FCI Office in Thuin for the way in which our documents were at all times sent promptly and correctly translated to our members, our thanks also go to the General Committee and its representative in our Commission, Dr Tamàs Jakkel, who supported and defended our proposals.

FCI COMISSION FOR SIGHTHOUND RACES – ACTIVITY RAPORT

2019 was a very active year for the international sighthound sports:

- an FCI European Championship Coursing in Pärnumaa (Estonia);
- an FCI European Championship Racing in Gelsenkirchen (Germany);
- more than 80 international coursing events;
- more than 60 international racing events.

Besides the annual Commission meeting, the President and Secretary of the Commission also had a very interesting meeting on 14.01.19 at the FCI Head Office with Gerard Jipping, Member of the FCI General Committee and responsible for our Commission, and Yves Declercq, Executive Director of the FCI.

Meeting of the Commission

The Commission has 2 major priorities:

- Allocation and supervision of the FCI title championships;
- Keeping the 'FCI Regulations for International Sighthound Races and Lure Coursing Events' and the 'FCI International Guidelines for Lure Coursing Judges' up to date.

The annual meeting of the FCI Commission for Sighthound Races (CdL) took place on Wednesday 19.06.2019 in Pärnu, Estonia. Traditionally, our meeting is held together with the European Championship Coursing. On our meeting, 16 countries were represented by their delegates, 4 countries were excused, 4 were absent. The meeting started with the election of the President and Secretary of the Commission for the next period. Willem Vermaut from Belgium was re-elected president and Chris Bekker from the Netherlands was reconfirmed as Secretary.



The meeting confirmed the following schedule for the FCI title Championships Coursing and Racing 2020:

- European Championship Coursing (ECC) 2020: Hungary, Tápiószentmárton - CdL-delegate: Slavomira Bozikova (SK) - www.ecc2020.hu
- World Championship Racing (WCR) 2020:
 Finland, Helsinki CdL-delegate: Chris Bekker (NL)

Shortly after our meeting, we received the following applications for

- European Championship Coursing (ECC) 2021: probably France
- European Championship Racing (ECR) 2021: probably Germany
- European Champion Coursing (ECC) 2022: probably Czech Republic

Our Commission is working to revise our international regulations. The updated version has to be ready and approved by January 1st, 2022. Therefore, the main agenda point of our meeting was discussing the many update-proposals of the different countries. This was well prepared in a 'change-list' with pros and cons by the working group and we could efficiently take the necessary decisions. The working group got a new mandate to prepare and present a draft version of the new regulations at our 2020 meeting. Following this meeting, we will finalise the new regulations and propose them in 2021 to the FCI General Committee.

The FCI Commission for Sighthounds Races has three working groups:

- Working Group for the 'FCI International Guidelines for Lure Coursing Judges'. This working group consists of 5 members (BE, DE, NL, NO and SE). The fifth version of these guidelines was approved by the FCI General Committee and have been valid since January 1st, 2019.
- Working Group for the 'FCI International Regulations for International Sighthound Races and Lure Coursing Events'. This working group consist of 5 members (AT, BE, DE, NL and SE) and is working very hard to revise the current regulations.
- Working Group for 'Weight Races'. This working group consists of 5 members (BE, CH, DE, FR and IT) and is exploring the possibility of 'weight racing'.

FCI Championships 2019

European Championship Coursing

The Estonian Sighthound Union hosted the FCI European Championship Coursing 2020 with almost 670 participants. The championship was held on 2 fields for 3 days. The fields and the surroundings were great, the technical teams did a great job and it was a pleasure to be in Estonia. Every day of this championship the dogs were judged by 10 different judges from 10 different countries. This is also the true meaning of a European championship! Estonia asked the help of Finland to organise this event. It is the fourth time in a row the organising country works together with other countries to organise the championship. Results are available on the FCI website.

World Championship Racing

The Deutscher Windhundzucht- und Rennverband (DWZRV) and the Verband für das Deutsche Hündewesen (VDH) hosted the European Championship Racing 2019 at the Windhundstation Emscherbruch of Windhundrennverein Westfalen-Ruhr, Gelsenkirchen. The championship was held for 3 days and there were 460 participants from 13 different countries. It was a very good and well-organised championship, with beautiful and highly exciting finals. Controls on the FCI title championships

On both FCI title championships, the Commission performed control measurements on all Whippets and Piccolo Levriero Italiano (PLI) participating and which were had not been measured before on an FCI title championship. On the ECC, 8 dogs were measured too high. On the ECR, 6 dogs were measured too high. On both FCI title championships, doping controls were performed. 2 dogs out of 6 were tested positive at the ECC and none was tested positive at the ECR.

Our happiness with the Commission's work was shadowed by the very sad news in June 2019 when we were informed that our dear and most respected President of the Commission since 2007, Mr Franco Mannato, passed away after a period of poor health condition. Personally, I had a close and good relationship with Franco. He was a passionate and dedicated sledgedog man, with a huge knowledge and experience as organizer, and as participant of sledge dog races, and as show judges we met several times at shows around Europe. I am convinced that Franco would be thrilled to know that the hard work in the Commission finally came through.






Team contest: 1 = Germany; 2 = Russia; 3 = Hungary

The 2020 FCI World Championship for Working Dogs will be held in Apeldoorn in the Netherlands.

The 2020 FCI-World Championship for Tracking Dogs will be held in Finland.

I want to thank all the delegates of the FCI Commission for Utility Dogs for their contribution and active work in 2019.

I also want to thank the FCI General Committee for the positive support and acceptance of our proposals, which shows their appreciation of our work.

- 2. Discussing the presentation (regulations, rules) of the Commission
- 3. Elections of the Board of the Commission
- 4. Discussing previously-sent countries' proposals and presentations



The meeting was warmly welcomed and opened by the President of the FCI Mr Tamas Jakkel.

Since the very beginning, a collaborative and constructive spirit prevailed. The delegates extensively and enthusiastically discussed the vision, mission and goals of the Commission. Discussion was followed by unanimous approval of the Commission's rules and regulations.

An important part of the meeting was elections of the Board of the Commission. By unanimous voting of the participants of the meeting, Mrs Ramune Kazlauskaite (Lithuania) was elected President of the Commission, and Mrs Monica Merima (Estonia) and Mr Alpay Ozkan (Turkey) Vice-presidents.

Good practices and insights regarding both the field of education and public relations were presented by some delegates. They were gladly accepted and thoroughly discussed. The Commission decided to scrutinise and prioritise the ideas for making proposal for the FCI Board. Collection of information and experience of the FCI member countries was decided to be the starting point for suggesting further activities.

The date of the next meeting was decided to be 25 November 2020 in Hungary, followed by the international conference on 26 November 2020.

FCI COMMISSION FOR MONDIORING – ACTIVITY REPORT



On 2-6 October 2019, the Mondioring World Championship organised by the Polish canine organisation took place in Nędzą, Poland at the LKS 1908 Nędza sports center. A total of 96 competitors from 26 countries took part in the competition, including competitors from the USA, Brazil, Israel, Kazakhstan, Uzbekistan, Ukraine and Russia from outside Europe; with Belgian Shepherd, Dutch Shepherd, German Shepherd and Doberman dogs.

A total of 21 competitors (1 disqualified) took part in the Category 1 Grand Prix. First place was taken by Ivan Mazorova with the dog Aristos Vilerrah, with 197 points / 200, Czech Republic

Howard Green (UK) and the dog Jotunheim Traveling Man came second with 188.5 points / 200.

Third place was taken by Frida Olsson (Sweden) with the dog Cherberos Carma, with 178.9 points / 200.

18 competitors took part in the Grand Prix cat 2. First place: Gwendoline Sonck (Belgium) with the Onix van't Stekkerke, 285 points / 300.

Second place: Nuno Barreto (Portugal) with dog Durgha do vale da Lobagueira with 260 points / 300.

Fabrise Basnier (France) took the third place with the dog Matrix de la vallee de luvry, with 256.5 points / 300.

53 competitors took part in the Category 3 World Championship (one did not start, one injury, one disqualification). The first place went to the competitor from Austria, Martina Praunias, with the dog Lasco vom Satansberg, with 368 points / 400.

The second place went to Stefan Bittner (Austria) with the dog Egon Eloy from the House of Wolfs, with 365 points / 400.

Third place went to Francesco Paolo Pecora (Belgium), with his dog Oakley 345 points / 400.

The following countries won in teams: 1 Austria

- 2 Belgium
- 3 USA



On 4-6 October 2019, an international selection of decoys took place, in which 30 candidates took part. The top five were: 1 Axel Villain (France)

- 2 Morgan Thomas Blanchard (Portugal)
- 3 Tommy Verschueren (Belgium)
- 4 Cédric Gottfreund (France)
- 5 Jean-Michel Shweyen (Belgium)

The judges of the international selection of decoys were Martial Beyaert (France), Alex Bondar (Romania) and Radim Kelar (Czech Republic).

Judges in category 3 were: Marc Willems (Belgium), Jean-Maurice Willig (France); Commissioner: Stéphane Huber (Switzerland); helpers: Madalin Dragan (Romania), Kees Verbunt (Belgium) and, due to the large number of players in the category, the third helper was Ivan Schuvalov (Russia), the reserve helper François Massart having suffered an injury at the decoy international selection. Judges Gran Prix in categories 1 and 2 were Martial Beyaert (France), Alex Bondar (Romania); Commissioner: Radim Kelar (Czech Republic); helpers: François Massart (USA), Dawid Dudek (Poland).

Supervisor of the Mondioring WCh was Valeer Linclau (Belgium); on behalf of the ZKwP, the championship commissioner was Ms Małgorzata Kędziorek.

Due to the large number of competitors, after consultation with team leaders on October 2nd, the Gran Prix started in category 1. 3.10, category 2 took place. From 4.10 to 6.10 there were starts in category 3. There were no extraordinary events during the competition. Two dogs were injured. The helpers F. Massart and M. Dragan also suffered an injury.

Conducting the Mondioring World Championships 2019 at such a high level, with such a number of players, was possible thanks to the cooperation and mutual assistance of people from the Czech Republic, Poland, France, Denmark, Austria, Slovakia, Ukraine and Greece, among others, members of the Mondioring Silesia club, Mondioring Klub CR, Dudla Parta, Republika Pod Psem.




BALANCE SHEETS (as of 31/12)



Letter of Understanding between FCI and AKC

WHEREAS the Fédération Oynologique Internationale (FCI) and The American Kennel Club (AKC) share the common goals of promoting and protecting purebred dogs; and

WHEREAS the parties hereto have in the past cooperated to a certain extent in carrying out this object and have been acting pursuant to certain informal agreements made from time to time for that purpose; and

WHEREAS it is agreed that the relations between AKC and FCI and its member registries should be explicitly written with a view towards future cooperation;

NOW, this letter of understanding encompasses the mutually agreed to basis for the relationship between the parties as follows:

- AKC will recognize the pedigree for any FCI registry that meets AKC requirements and that wishes to have such recognition.
- AKC will not automatically give exclusive recognition to the FCI registry in any country in which there are multiple registries and FCI will not automatically give exclusive recognition to AKCs registry in the United States.
- 3. AKC will not register any dog born in an FC member country until that dog has been registered in the Stud Book of the FC registry or the AKC-recognised registry in that country. No dog born in the USA, belonging to breeds recognised by the AKC, will be registered by an FC member registry unless the dog has been registered in the FC-recognised registry in the United States. It is up to the FC to decide about the registration of dogs born in the USA belonging to breeds not recognised by the AKC.
- 4. Each of the parties agree that when any information comes to its knowledge which might reasonably affect or be useful to the other party (AKC judges suspension, amended standards, etc.), it will immediately communicate such information to the other party.
- FCI and AKC will deal with the judging approval reciprocity in a separate document (see attachment).



- 6. AKC will not sponsor any event in the country of an FQ member without the express permission of FQ and the FQ member. FQ will not sponsor any event within the territory of the United States without the express permission of AKC. Puerto Rco is exempted from this provision as both AKC and FQ have been previously sponsoring activities on that island.
- 7. While not an FQ member, FQ has graciously agreed to permit AKC to participate in its World or Section Agility, Utility, Obedience, etc. Championship Championship Event provided that this participation does not prevent representative teams of FQ member organisations from taking part. If the AKC teams win the competition, they are not eligible for the title of FQ Winner at these events.
- AKC registered dogs are eligible for the title of FC International Champion under specific conditions to be agreed upon by the AKC and FC.
- Except with the agreement of the AKC, the FCI will not register kennel names for breeders living in USA (with exception of Puerto Rico) and, except with the agreement of the FCI, the AKC will not register kennel names for breeders living in countries where the FCI has a member, which the AKC has accepted.
- 10. FCI agrees to send to the AKC headquarters all revised breed standards and AKC agrees to send to the FCI headquarters copies of its Complete Dog Book, which includes all AKC standards, each time that such publication is revised.
- 11. The terms of this letter of understanding is agreed to by the parties listed below. This agreement may be terminated by either party upon reasonable notification to the other party.

Breed Judging

At FCI CACIB international shows, the AKC judges are eligible to judge and award the CACIB provided that the two following conditions are fulfilled:

- the breeds they are scheduled to judge are recognised by the AKC (this does not include FSS and Miscellaneous classes).
- the judges in question are allowed to judge, under AKC regulations, the breeds in question at AKC events and award them championship points. An AKC judge, residing in the United States, may not be approved as an FQ judge (breed, group, all breed) eligible to award CACIB.

At AKC events, the FCI judges are eligible to judge and award championship points provided that the following conditions are fulfilled:

- the breeds they are scheduled to judge are recognised by the FQ and by the national kennel dub, in their country of residence, which has jurisdiction over the judges in question
- 2. the judges are members of their national kennel dub, in their country of residence, which is an FCI member or contract partner
- 3. the judges in question are allowed to judge, under FCI regulations, the breeds in question at FCI International CACIB shows and award them the CACIB

Group and BIS Judging

It is up to both, the AKC and the FO members, to choose to invite or not a judge to judge a particular group (according to FO or AKC breed nomenclature) at an AKC event or at an international FO CAOB show taking into consideration the experience of the judge, his judging credentials and the breeds and their numbers in the groups to judge.



Letter of Understanding between the Fédération Cynologique Internationale and the Kennel Club

WHEREAS the Fédération Cynologique Internationale (FCI) and the Kennel Club (KC) share the common goals of promoting and protecting, in the case of the FCI, pedigree dogs and in the case of the Kennel Club, all dogs; and

WHEREAS the parties hereto have in the past cooperated to a certain extent in carrying out this object and have been acting pursuant to certain informal agreements made from time to time for that purpose; and

WHEREAS it is agreed that the relations between KC and FCI and its member registries should be explicitly written with a view towards future cooperation;

NOW, this letter of understanding encompasses the mutually agreed basis for the relationship between the parties as follows:

- The KC, where it recognises the breed in question, will recognise the pedigree
 of any FCI registry that meets KC requirements and that wishes to have such
 recognition.
- 2. In so far as it is lawful, the KC will give exclusive recognition to the FCI registry in any country in which there are multiple registries provided that these registries meet KC requirements and the FCI will give exclusive recognition to the KC's registry in the United Kingdom. For the time being this will not include Malta and China.
- 3. The KC will not register any dog, or issue a pedigree to any dog, born in an FCI member country whose registry the KC recognises, until that dog has been registered in the FCI registry in that country. No dog born in the UK will be registered, or have a pedigree issued, by an FCI member registry unless the dog has been registered by the KC in the United Kingdom.
- 4. Each of the parties agree that when any information comes to its knowledge which might reasonably affect or be useful to the other party (KC or FCI judges suspension, amended standards, etc.), it will immediately communicate such information to the other party.
- 5. The FCI and the KC will endeavour to agree on the conditions to make their respective judges eligible to officiate at events sanctioned by them (FCI and KC).
- 6. The KC will not sponsor or support any event for dogs in the country of a current FCI member without the express permission of the FCI member. The FCI will not sponsor or support any event for dogs within the territory of the United Kingdom without the express permission of the KC. For the time being this will not include Malta and China.

- 7. While the KC is not an FCI member, the FCI has graciously agreed to permit the KC to participate in its World or Section Agility, Utility, Obedience, etc. Championship Event provided that this participation does not prevent representative teams of FCI member organisations from taking part. The KC teams may win the competition but are not eligible for the title of FCI Winner at these events.
- The FCI agrees to send to the KC headquarters all revised breed standards and the KC agrees to send to the FCI headquarters copies of all revised breed standards. The FCI and KC will discuss health issues connected with breed standards on a regular basis.
- FCI members are allowed to refer to the title of UK Champion by using the abbreviation "UK Ch + name of the dog".
- 10. Except with the agreement of the KC, the FCI will not register kennel names of breeders living in the UK and, except with the agreement of the FCI, the KC will not register kennel names of breeders living in countries where the FCI has a member, which the KC has accepted.
- 11. The terms of this letter of understanding are agreed to by the parties listed below. This agreement may be terminated by either party upon reasonable notification to the other party.

AGREEMENT ON THE MUTUAL RECOGNITION OF DOG SHOW JUDGES BETWEEN THE KENNEL CLUB AND THE FEDERATION CYNOLOGIQUE INTERNATIONALE

This agreement refers only to the mutual recognition of judges, hereinafter referred to as 'FCI Judges' who are resident in a FCI member country and are listed as designated 'International Judges' in the Judges Directory published by the Fédération Cynologique Internationale (FCI), to award Challenge Certificates and to judge Groups and Best in Show at Kennel Club licensed Championship Shows, and for UK resident judges to award Certificats d'Aptitude au Championnat International de Beauté (CACIBs) and to judge Groups and Best in Show at International FCI CACIB Shows held under the auspices of the Fédération Cynologique Internationale (FCI). Furthermore, all other recognised canine activities such as competitive obedience, agility, field trials, working trials etc. are specifically excluded.

1. This agreement will commence on the 1st day of May in 2017 and will be valid for a period of not more than 5 years, subject to the right of termination by one or other of the parties, no less than six months prior to the date of expiry.

2. Subject to six months' notice, this agreement may be amended at any time by mutual agreement of the parties concerned.

3. This agreement is predicated on the basis that the Kennel Club (KC) and Fédération Cynologique Internationale (FCI) have agreed to recognise and respect their respective schemes for the approval, education and training of dog show judges.

Approval to award Kennel Club Challenge Certificates

4. The Kennel Club will accept nominations for approval, in accordance with Kennel Club Rules and Regulations and appropriate Codes of Best Practice as published and amended from time to time, to award Challenge Certificates to a breed(s) for the first time, without requesting completion of a Kennel Club questionnaire, for FCI Judges resident in a FCI member country provided they are suitably experienced, having previously awarded CACIBs to the relevant breed(s) in countries other than their country of residence for a minimum period of 5 years prior to their first UK appointment for the breed(s).

5. All such nominations will continue to be subject to the approval of the Kennel Club's Board.

FCI

6. FCI Judges resident in a FCI member country who are approved to award Challenge Certificates to a breed for the first time on the basis of mutual recognition may be subject to evaluation when carrying out the appointment. Approval for subsequent appointments to award Challenge Certificates for the same breed will be subject both to the outcome of any evaluation and the proviso that the judge remains in good standing.

7. FCI Judges resident in a FCI member country who were previously approved to award Challenge Certificates at Kennel Club licensed Championship Shows prior to the signing of this agreement will continue to be considered for approval for subsequent appointments, subject to the proviso that they remain in good standing.

Approval to judge Groups and Best in Show at Kennel Club Licensed Championship Shows

8. FCI Judges resident in a FCI member country who were previously approved to judge Groups and Best in Show at Kennel Club licensed Championship Shows prior to the signing of this agreement will continue to be considered for subsequent appointments, subject to the proviso that they remain in good standing.

9. The criteria to be applied in the case of FCI Judges resident in a FCI member country who are nominated, subsequent to the signing of this agreement, to judge Groups and Best in Show for the first time at Kennel Club licensed Championship Shows will be the same as those applicable to UK resident judges.

10. All such nominations will continue to be subject to the approval of the Kennel Club's Board.

Approval to award Fédération Cynologique Internationale Certificat d'Aptitude au Championnat International de Beauté (CACIBs)

11. UK resident judges who remain in good standing and have previously awarded Challenge Certificates in the UK will be eligible to award CACIBs to the relevant breeds provided that they are suitably experienced.

Approval to judge Groups at International FCI CACIB Shows

12. UK resident judges who have previously been approved to award Challenge Certificates in 50% or more of the breeds that are allocated Challenge Certificates by the Kennel Club, in an FCI group, will be eligible to be approved to judge the relevant group at International FCI CACIB Shows, subject to the proviso that they remain in good standing.

13. UK resident judges who remain in good standing and were previously approved, prior to the signing of this agreement, to judge one or more Groups at International FCI CACIB Shows will continue to be recognised as approved to judge the relevant group(s).



Approval to judge Best in Show at International FCI CACIB Shows

14. UK resident judges who remain in good standing and have judged five or more FCI groups will be eligible to be approved to judge Best in Show at International FCI CACIB Shows.

15. UK resident judges who remain in good standing and were previously approved to judge Best in Show at International FCI CACIB Shows prior to the signing of this agreement will continue to be recognised by the FCI as approved to judge Best in Show.

Memorandum of Understanding between FCI and CKC

WHEREAS the Fédération Cynologique Internationale (FCI) and The Canadian Kennel Club (CKC) share the common goals of promoting and protecting purebred dogs;

WHEREAS the CKC and the FCI have, in the past, cooperated to a certain extent in carrying out these goals and have been acting pursuant to certain informal agreements made from time to time for that purpose;

WHEREAS it is recognized that both the FCI and the CKC are required to operate within the limits of the legislation governing their activities, including their respective constitution and by-laws;

NOW this letter of understanding expresses a mutually agreed to basis for the relationship between the CKC and the FCI as follows:

- The CKC acknowledges the role of the FCI and its governing institutions as set out in the FCI Statutes as the primary world federation of dog registries.
- 2. The FCI acknowledges the CKC as the primary kennel club in Canada.
- The CKC and the FCI agree that when any information comes to the knowledge of one party, which might reasonably affect or be useful to the other party (judges suspension, amended standards etc.), it will immediately communicate, in writing, such information to the other party.
- The parties will meet at the request of either of them, within a reasonable timeframe and on basis of a consistent mutually agreed agenda which will include matters of common interest.



- 5. The FCI agrees to send to the CKC head office a copy of all breed standards with revisions as they occur and CKC agrees to send to the FCI headquarters all CKC breed standards with revision as they occur. The FCI and CKC will also share information concerning the decisions of their respective governing bodies such as the exchange of official publications.
- 6. The CKC will periodically provide the FCI with a list of the registries from the FCI member countries with which the CKC has reached an agreement providing for the mutual recognition of studbooks and pedigrees. The CKC will get in touch with all the FCI members and contract partners and inform them about the procedure to follow to gain CKC recognition. The FCI will notify the CKC of the accession of any country to FCI membership.
- The details of a mutual recognition of FCI and CKC judges are written on a document which is part of this contract.
- The FCI will not sponsor or sanction any event within Canada without the express permission of the CKC.
- The CKC will not sponsor or sanction any event in an FCI member country without the express permission of the FCI and the agreement of the member country.
- 10. While not an FCI member, FCI graciously agrees to permit CKC to participate in its World or Section Agility, Utility, and Obedience Championship Events and any forthcoming canine performance event that may be mutually recognized by both organizations.
- 11.As long as no agreement is reached with regard to the working breeds (according to the FCI nomenclature) between the FCI and CKC, these breeds (CKC-registered dogs) are not eligible for the title of "International Beauty Champion". The non-working breeds (CKC-registered dogs) are eligible for this title provided that they comply with the FCI International Championship Regulations, i.e. 4 CACIB in 3 countries under 3 different FCI judges.
- 12. The CKC registered dogs are eligible for the other FCI international titles provided that they meet with the FCI requirements.
- 13. The FCI international directory of kennel names (affixes) is not open to CKC breeders and the FCI cannot guarantee that a CKC kennel name (affix) will not be similar to an FCI registered kennel name (affix) and conversely.



- 14. Both parties agree that the present Letter of Understanding shall not be interpreted or applied so as to require either party to act in a manner not authorized by or contrary to applicable legislation, including each party's constitution, rules or by-laws.
- 15. The terms of this Letter of Understanding are agreed to by both parties. This agreement may be terminated by either party upon giving the other party 60 days notice in writing.

CKC Judges eligibility to officiate at FCI International Events

From April 1st, 2009, the following dispositions will apply:

- a) CKC judges are allowed to judge in the FCI member countries all-breed, group and specialty national shows, the breeds they are approved to judge in Canada.
- b) CKC judges who have already judged international FCI CACIB shows before December 31st, 2007, are allowed to award CACIB at international FCI CACIB shows, FCI World and Sections shows, to the breeds they are approved to judge in Canada.
- c) Once a CKC judge has judged four (4) national shows in four (4) different FCI member countries by the FCI breed standards, he/she is allowed to award CACIB to the breeds he/she is approved to judge in Canada.

It will be the responsibility of the FCI Office and of the judges concerned to keep track of assignments undertaken in an FCI member country. Taking into account the legal restrictions on the exercise of extra-territorial jurisdiction by the CKC, it will be the responsibility of the CKC to communicate them to their judges and the practical implementation and enforcement of the agreed above principles will be under the responsibility of the FCI Office, of the FCI members and the judges concerned.
