NOTE - CONSTITUTION, Article 21 - JURISDICTION OF KENNEL UNION
 Every person (a) making application to the Kennel Union for the registration, recording or transfer of a dog or the registration of an affix; shall be deemed thereby to have submitted to and agreed to be bound by this Constitution and all Schedules, with particular reference to Schedule 9, Code of Ethics, Rules, Regulations and By-Laws framed thereunder, both in respect of himself and in respect of every dog owned by him, registered or recorded in his name or owned, registered or recorded by him jointly with another or others or owned or registered or recorded in the name of a nominee, or exhibited or handled by him.
