FCI UTILITY DOGS COMMISSION

a) Presentation

The Utility Dogs Commission is one of the non-mandatory commissions of the FCI. The assignment of the commission is to represent, to organize and to take care of the good functioning of the Utility dogs sport. The Utility Dogs Commission is made up of delegates from countries which are a member of the FCI and want to have a representative in this commission. National Organisations which are interested can report this to the FCI General Assembly or to the FCI Secretariat.

To become effective, all decisions made in the commission, have to be approved by the General Committee.

The Utility Dogs Commission is led by a president and two vice-presidents, chosen by the delegates of the commission.

The Utility Dogs Commission makes and keeps up to date the rulebooks for Utility Dogs Sport, the World Championships for Utility and Tracking Dogs, and for example the "Guidelines for International Working Dog Trials and International Tracking Dog Trials of the FCI" (IPO).

The Utility Dogs Commission also supervises Utility Dog trials where the "CACIT" can be awarded and the "FCI International Working Champion Titles". The Utility Dogs Commission allocates the World Championships for Utility and Tracking Dogs to the FCI-member countries, nominates the judges for this World Championship, organizes seminars for judges, etc.
