## INTRODUCTION

Established in 1911, the FCI includes 98 Members and Contract Partners (one member per country). Each Member issues their own pedigrees and train highly-qualified judges. The FCI makes sure that the pedigrees and judges are mutually recognised by all the FCI members, Contract Partners and any person involved in their domestic canine scene.

In accordance with the celebration of the 100th Anniversary of the Fédération Cynologique Internationale, the FCI General Committee reviewed its Mission, Vision Statement and Values to maintain the Association's leadership worldwide.

In 2018, further to the decision of the FCI Extraordinary General Assembly, FCI's Mission, Vision Statements and Values were revised as follows:

## MISSION AND VISION STATEMENT

The FCI is the highest authority of the canine culture and supports, via its Members and Contract Partners, the well-being of pedigree dogs worldwide as well as their selective breeding and generational registrations.

The FCI is responsible for safeguarding pedigree dogs' health and international pedigree dog activities to enhance the relations between dogs and humans.

The FCI recognises that the following principles and professional responsibilities are fundamental for the well-being of all pedigree dogs worldwide:

## VALUES

- a/ The FCI considers pedigree dogs' health, temperament and behaviour of utmost importance in Breed Standards.
- b/ The FCI promotes pedigree dogs' activities and sports worldwide, which it considers beneficial for the pedigree dogs.
- c/ The FCI entrusts its commissions to make recommendations about other important matters.
- d/ The FCI divides geographically the world of pedigree dogs through its three (3) sections.
- e/ The FCI trusts its Members and Contract Partners to protect the integrity of their National Registries.
- f/ The FCI recognises and respects agreements with non-member national organisations.
- g/ The FCI sets the highest standards for its Head Office.
- h/ The FCI ensures the regular celebration of World and Section Championship events.

## INTRODUCTION

La FCI est responsable de la préservation de la santé des chiens avec pedigree et des activités internationales impliquant des chiens avec pedigree, dont le but est de promouvoir les relations entre le chien et l'Homme.

La FCI reconnaît que les principes suivants et les responsabilités professionnelles sont fondamentaux pour le bien-être de tous les chiens avec pedigree dans le monde entier :

## VALEURS

- h/ La FCI veille à l'organisation régulière de championnats du monde et de section.

## INTRODUCCIÓN

La FCI reconoce que los principios a continuación y las responsabilidades profesionales son fundamentales para el bienestar de todos los perros con pedigrí del mundo :

- f/ La FCI respeta y acepta los acuerdos tomados con organizaciones nacionales de países que no son miembros.
- g/ La FCI es extremadamente exigente con su oficina central.
- h/ La FCI se encarga de las celebraciones periódicas de los Campeonatos Mundiales y de Sección.

## EINLEITUNG

Die FCI wurde in 1911 gegründet und hat 98 Mitglieder und Vertragspartner (ein Mitglied pro Land). Jedes Mitglied erstellt seine eigenen Ahnentafeln und bildet hochqualifizierte Richter aus. Die FCI stellt sicher, dass die Ahnentafeln und Richter innerhalb der FCI von allen Mitgliedern, Vertragspartnern und allen in der Hundeszene tätigen Personen anerkannt werden.

Im Rahmen des 100-jährigen Jubiläums der Fédération Cynologique Internationale hat der FCI-Vorstand seine Mission-Statement und seine Vision-Statement sowie die Werte überarbeitet um die weltweite Führungsposition der Vereinigung in der Kynologie zu erhalten.

In 2018 wurden nach Beschluss der Außerordentlichen Generalversammlung der FCI Mission-, Vision- Statement und Werte der FCI wie folgt überarbeitet:

## MISSION UND VISION-STATEMENT

Sie ist für die Gewährleistung der Gesundheit von Hunden mit Ahnentafel und internationaler Aktivitäten mit Hunden mit Ahnentafel zur Förderung der Beziehungen zwischen Hunden und Menschen verantwortlich.

- d/ Die FCI unterteilt die Welt der Hunde mit Ahnentafel geographisch anhand ihrer drei (3) Sektionen.
- e/ Sie vertraut ihren Mitgliedern und Vertragspartnern, dass sie die Integrität ihrer nationalen Register schützen.
- f/ Die FCI anerkennt und respektiert Abkommen mit nationalen Hundeverbänden, die keine FCI-Mitglieder sind.
- g/ Für ihre Geschäftsstelle setzt sie höchste Maßstäbe.
- h/ Die FCI sorgt für die regelmäßige Durchführung von Championaten auf Welt- und Sektionsebene.

## Major decisions and most important facts in 2023

As you will read, the year 2023 was very rich in events and decisions. I have tried to give a summary so that the readers will be properly informed or remembered about the majority of them.

- In January, the part "contacts" of the FCI website has been totally reviewed, securing the personal data of any person involved in the official daily work of the FCI (commissions members, general committee members, NCO's employees and officials, etc.).
- In January and March, our FCI Committee for Welfare and Health of Dogs published two new brochures "**Preparing and Caring for your Puppy**" and "**Guidelines for FCI Show Judges**". Both interesting documents are available at <https://fci.be/en/Welfare-well-being-and-protection-for-pedigree-dogs-worldwide-1291.html>.
- In June, the FCI and NKK conducted the FCI/NKK BOAS Seminar and Functional Grading Workshop in Oslo, with the highly appreciated participation of Dr J.Ladlow.
- In June, the FCI Head Office informed the FCI Members and Contract partners that the different certificates (CACIT, CACIOB, CACIAG, etc) would no longer be printed and sent by post. They all are available online, just as the CACIB cards together with all the results in work and sport disciplines.
- Two new FCI titles, International Beauty Champion-Junior and International Beauty Champion-Veteran, CIB-J and CIB-V, were introduced from 1<sup>st</sup> August.

- The legal case opposing our Norwegian member (NKK) to the Norwegian Society for Animal Protection has been settled. Early October, the Supreme Court in Norway upheld the judgment of the Court of Appeal: breeding Cavalier King Charles Spaniel is in violation of the animal welfare act § 25 in Norway. However, English bulldog breeding remains legal provided that the dogs that are used get a health examination.
- In October, the FCI and its partner Royal Canin held a very interesting online Seminar called “Pro-Expert Forum”. For more general information, please click on <https://www.fci.be/en/PRO-Experts-FORUM-25-26-October-2023-4787.html>.
- Following the impossibility of our Ukrainian friends to host the 2024 FCI World Show, the General Committee voted to reassign the event to our Croatian colleagues, HKS. The 2024 FCI-WDS will therefore take place in April 2024, in Zagreb (HR).
- In November, the FCI General Committee approved the application of the Bulgarian National Federation of Cynology (BNFC) to become an FCI Contract Partner, meaning the return of Bulgarian cynology into the FCI sphere.

The FCI General Assembly (Geneva) has voted to grant the status of FCI full member to our friends from Kazakhstan and associate members to our friends from Mongolia. Welcome to both of them.

# FCI STANDARDS COMMISSION

## ACTIVITY REPORT 2023



We had held our annual Standards Commission meeting at Montevideo, Uruguay on, May 2nd 2023.-

The Standard Commission main work continues being to revise and adapt new and existing standards. Standards are always in continue evolution for different reasons, for new rules on the countries of origin, simple reality of the breed and making better wording, etc. but mostly focus on dog's health makes countries review the text in standards extra carefully to avoid wording that may result in interpretation that can lead to exaggerations that might cause health risks in the dogs, not forgetting to take special care to maintain always the type of the breeds.

The Commission thoroughly revises and amends standards continuously and the co-operation with the National Organizations is usually efficient. Still, the procedure must go through several steps before a standard can be changed and published, these documents are the backbone in the work of the FCI and its member countries.

Viewing of the text in standards from a health and welfare perspective has been intensified. This is not always about the wish of the countries of origin but, in the interest of keeping the breeds for the future, we all must realise that exaggerations in type as well as character issues in dogs might not only affect the health of the dogs, but it may also increase the risk to have breeds banned by law in some countries.

We had marked a working method within the commission; how to manage the standards since they arrive to the office until they are seen and discussed by the commission, then send back to the Country of Origin for acceptance and then to General Committee for their approval to be latter published.

We do insist on asking to the National Organizations collaboration on having a representative good drawing or picture to illustrate the front page of the FCI Standards as this will help a lot the comprehension of the hole standard.

We had also had communication through mailing deciding urgent matters or small changes that didn't had the need to wait for a presental annual meeting.

On this year General Assembly at Geneve, Switzerland, Petru Muntean and Jorge Nallem were re-elected as members of our commission and a new member has come in, Ricardo Torres Simoes from Brazil which we welcome.

Next meeting was decided by members of both commissions, Standard and Scientific, to take place at Timisoara, Romania on May 13 and joint meeting with Scientific Commission on May 14th 2024.

# FCI COMMISSION FOR AGILITY

## ACTIVITY REPORT

### COMMISSION MEETINGS

The first meeting of the year was held in the weekend of 4th and the 5th of February. It was again the first 2 days face to face meeting after the COVID Pandemic. It was held in the wonderful city of Prague (Czech Republic).

In 2023 we implemented changes to the Agility Rules and one of them was the introduction of a new height category called Intermediate (for dogs between 43 and 48 cm).

As this was an extra category there was a big challenge on creating a good schedule for our World Championship, without the adding of an extra day. As we also added 2 extra judges we needed to figure out how we could make sure that every judge would judge evenly over the different categories and classes. A good part of the February meeting was used to discuss and create this schedule.

The judges and obstacle guidelines were aligned with the 2023 rules and in this meeting we also confirmed the rules for the new (not yet official) Senior Open Agility World Championships (a championships for people above 55 years of age).

Other decision that were made during this meeting:

- Increase of the entry fee of the JOAWC and EO
- Belgium will be the host for the Agility World Championships in 2024
- Increase of judges for European Open events
- Voting and confirming the EO2024 and JOAWC 2024 judges.

The second meeting of the committee was held on October 9th, the day after the Agility World Championships in Czech Republic. We evaluated the AWC Schedule and came to the conclusion that the competition days started to early and ended to late. A decision was made to skip the training for the future, as this would provide us with half a day that could be used to run at least 1 or 2 categories. This should make sure that 1 or 2 days of the event could finish earlier.

We also needed to vote for the board of the agility committee again, to align with the General Assembly meetings. All current board members have declared their intention to stand for re-election.

# FCI COMMISSION FOR EDUCATION AND PUBLIC RELATIONS ACTIVITY REPORT

On 3 July 2023 the FCI Commission for Education and Public Relations organised an international conference “Who Represents Pedigree Dogs. Building Strategies to Promote Our Hobby”. The conference was hosted by the Lithuanian Kennel Club.

Prior to the conference, on 24 March, the Board of the Commission had online meeting where the aims and objectives, the concept, target audience, major themes and subthemes of the conference were discussed.

9 speakers from different countries gave their presentations during the conference and its outcomes were discussed and rounded up during the panel discussion at the end.

A day after the conference, on 4 July 2024, the annual meeting of the FCI Commission for Education and Public Relations took place in Vilnius, Lithuania, with the presence of 8 delegates of the FCI member countries and 2 guests.

The delegates of the Commission approved the annual report presented by the President of the Commission Ms. Ramunė Kazlauskaitė.

During the meeting, Mr. M. A. Casellas-Gil presented 4 versions for the Commission’s logo. They were discussed and the most acceptable option was voted for. Proposals for logo improvement were discussed. It was decided to work on the selected option and send the progress to the delegates of the Commission for their feedback and/or approval.

Further, Ms. Fleur-Marie Missant presented the Education program for breeders run by the French Kennel Club and offered sharing the materials with other FCI member countries. It was decided to add the program to the resource pool on the sharing platform.

In addition, Mr. M. A. Casellas-Gil presented a global campaign project “Dogs

bring us together” the idea of which is in unifying the message of protecting purebred dogs worldwide by means of creating a universal message on the importance of dogs for every culture and repositioning the role of purebred dogs in modern society. It was decided to collect the visuals from their organizations’ archives and that proposal will be incorporated in the proposals packet for the FCI General Committee for their approval.

Finally, the conference outcomes were discussed and the following conclusions were drawn:

- In communication about pedigree dogs it is important to reposition the dog from the product to the member of the family;
- Changing the image of the dog shows making them more open to the society;
- Creating partnerships with other stakeholders for public events while promoting pedigree dogs;
- Cooperating with other related FCI Commissions.

It was decided on the basis of the above to make proposals for the FCI General Committee.

Next meeting of the Commission was planned for spring - summer 2024. The member countries are welcome to propose the host country for the meeting and the final decision will be taken by online voting.

On behalf of the Board of the FCI Commission for Education and Public Relations I would like to thank all the delegates of the Commission for their work, commitment and fruitful discussions that we had during and in between the meetings of the FCI Commission for Education and Public Relations.

# FCI COMMISSION HERDING DOGS

## ACTIVITY REPORT

Herding instinct is a complex of many characteristics and abilities which makes dogs of different breeds useful to control flock animals. Livestock protecting is strongly stuck to this domain as well, therefore our commission handles the questions of such dog breeds as well. The variety of breeds and their work style are a range on a huge scale, therefore it is a rather difficult task to find out tests and trials suitable for all of them. However our aim is clear: to provide an FCI framework to maintain these instincts and abilities for the future generations of these dogs.

After a long preparation to work out new rules (for livestock guarding breeds) and amending ones (for herding breeds), they were validated by the FCI in 2023. Our work continued with the preparation of a judges seminar and the organization of the 1st FCI TS Herding European Championship. As these activities together with our meetings took away most of our efforts, this time our annual report will reflect on the concerning results. The herding activities of member countries are also a very important issue, therefore that statistical summary will be published on our FCI webpage later.

The year started with a very new form of Traditional Style (TS) judges seminar, where 8 countries with 27 participants (17 judges) spent a weekend at Szaporca in Hungary on 12th-14th May 2023. On day one the new rules and the amendments were introduced and the modified scoring system was explained by the president of FCI HDC. The new approach gave a bigger freedom for judges, but on the other hand, higher responsibility too. Next, all the judges had to judge of two FCI TS runs (IHT-3, IHT-2) on the nearby field. There was a flock, well-prepared to be handled by dogs, of about 30 Racka sheep. Kiss Barbara (our host judge) had been asked to prepare tasks and passages for the competitors. The judges were outside of the field, but still had a chance to see all activities. Two cameramen recorded the runs from different points of view. After the runs all the anonymous score sheets were used for statistical analyses. Based on this, a long discussion started which provided themes, until into the late night. The next morning the recorded IHT-3 run was displayed again in a lecture room. By watching the run step-by-step with different points of view, it gave a chance to detailed discussions on the different evaluations. As a result of the seminar the participants learned a lot from each other and started to understand the different points of view of evaluations. Despite of its complexity, many common points were realised, so a kind of general understanding started to be formed. The participants agreed on the usefulness of such a seminar and the Dutch delegates expressed their willingness to hold the next seminar in The Netherlands.

Breeders and owners are equally interested in achieving FCI titles and winning awards with their dogs, so the suitable FCI tests and trials are good opportunities for them. As our commission declared that herding and livestock guarding cannot be categorized as a pure sport, new administrative

challenges appeared out of this statement. In this case due to FCI rules, only breeds subject to a working test can achieve FCI titles and awards. It caused a huge confusion not just in our commission but all around the herding world. Many of the competitors were upset, as most of their breeds had no more chance to take home the gained FCI results. Solving this long lasting problem was/is the main priority of our commission. Together with the FCI Office and with the special help of Mr. Yves de Clercq, FCI Executive Director, a letter was sent on July 3rd, 2023 to each and every NCO to express their wish concerning their native breeds. Only the nation of the origin of a breed has the right to declare any purpose about this issue, if the breed is not subjected to a working test. Therefore in our letter we kindly ask to select one of the next four options by November 1st, 2024:

- The breeds status remains unchanged („without working trial”) but these breeds can however be entered in working class at all international FCI-CACIB shows. In that case, the breeds will be included in the list of FCI of breeds that are not subject to a working trial, but can **HOWEVER** be entered (with WCC - Working Class Certificate) in working class :

- The FCI Breeds Nomenclature can be updated with an „optional working trial”
- The FCI Breeds Nomenclature can be updated as follows „With working trial”:
- The breeds status remains unchanged (not submitted to a working test) and the breeds are not eligible for FCI working classes at international FCI-CACIB shows, FCI working/herding titles and awards

Till the end of 2023 only 7 countries from the involved 29 had answered, the majority positive, but unfortunately some chose possibility d). Hopefully by the deadline we can inform the herding world with a much better result.

In the middle of summer on 1st July our Commission held an online meeting where we discussed the next topics: Status of our amended rules, Presidents explanations and experience of the Judges Seminar, Status of European Herding Championship, Questionary form of Herding Situation in countries (containing annual event calendar in advanced), Date for our postponed meeting (Sweden). Even if the online meeting cannot replace face-to-face meetings, they are useful tools for our work.



In 2017, the rule of FCI TS HEC was born in Interlaken (Switzerland). All herding dogs excluding Border Collies are allowed to compete in this trial. This distinction was made because of the unique herding style of Border Collies for whom the so-called Collecting Style (CS) events were created exclusively and where no other breeds are allowed to compete.

In 2018, in Helsinki (Finland), the application letter of Hungarian Kennel Club (MEOESz) signed by President András Korózs, was accepted by the FCI, making Hungary the first to successfully win the right to host the Herding European Championship in 2020. The COVID-19 epidemic and the pandemic period that accompanied it, prevented the event from being held for a long time, but finally it was able to successfully be organised in Hortobágy on 22nd-24th September 2023.

With the cooperation of MEOESz and the Hortobágy Gene Preservation Nonprofit Ltd. and the support of many sponsors and volunteers, the event was realized after a thorough preparation. For the European Championship each nation was allowed to enter two competitors and one reserve. Each country was responsible for selecting its own national team.

Each country had qualified its competitors for at least one year and delegated the best of them. At the closing of the entries, 18 competitors from 10 countries and 4 reserves were waiting for the opening ceremony on Friday 22nd September 2023 at 16:00.

The programme of events for the national teams and their company is certainly worth mentioning, as it laid the foundations for the success of the whole weekend. Immediately after the opening ceremony, the guests were taken in horse-drawn carriages to the beautiful world of the Hortobágy Puszta. During the short but extensive journey, they saw a special horseman show, a flock of several hundred racka sheep, a stud and a grey cattle herd. Finally, after a “Welcome drink” from pálinka heron-well, the competitors were able to read their start numbers, which they found on the bottom of the glasses. These moments became an everlasting memory, with the fading light of the sun setting in the vastness of the Puszta and the sight of animals grazing around the heron-well. To have been able to capture these moments and the love of the Hortobágy puszta, it will live in our memories for ever.

Hortobágy, as the defining pillar of Hungarian pastoral culture, was an inevitable choice for the location of the competition. The competitions took place on a 64 m x 109 m fenced field in the riding arena of Hortobágy-Máta. On the first day, 23rd September 2023, all the competitors took to the course, judged by a pool of three international judges: Prof.dr. Luigi Guidobono Cavalchini, head judge from Italy, André Roller from Germany and Barbara Kiss from Hungary.

For the qualification runs, 100 sheep were provided and were divided into flocks of 20 sheep. Each competitor entered the field with a new flock, on which they had to perform the tasks according to the FCI Traditional Style herding rules, as determined by the judges. Despite the fact that the judges set the competitors a particularly difficult task and that Racka sheep are naturally flighty animals, we could see beautiful runs. There was driving over a bridge, driving through traffic, grazing, catching a sheep, passing a prohibited area, stopping, penning, and many other tasks.

It would be difficult to highlight any competitor, as each one of them put on a unique and memorable performance. In fact, it is safe to say that all of them, without exception, competed with the best dog in the world. Because the real value of the work invested together is the priceless, intimate and irreplaceable bond that develops between the pair during the years of education.

In addition to the qualification runs, there was a double CAC show for the five Hungarian herding breeds, followed by a joint Best in Show programme. Besides there were the permanent programmes of Hortobágy National Park Puszta buses (horse-drawn carriages), departing frequently towards the Puszta attractions, the Bird Hospital, the Crafts Courtyard, the Csárda, etc.

As a special attraction anyone could have their photo taken in front of the background of the traditional Debrecen market in borrowed folk costumes, and even shop at the market of folk artists and craftsmen products.

Back to administrative work again...

After the end of the herding event season on 25th-26th November 2023 in Stockholm (Sweden) our Commission held a meeting (in person). At this point we must say thank you very much for the hospitality of SVENSKA KENNELKLUBBEN. They made our work comfortable and effective and helped our activity in many ways. On the meeting we had a special guest and expert invited by our commission (unanimously voted on 1st July 2023). Sandra von Erlach who was previously Switzerland's delegate and our Secretary for decades and one of the drafters of the CS regulations. After the general part of the agenda the participants selected Jouni Kautto (Finland) as Secretary of our Commission. Next we handled the questions of CS Rules amendments (FCI-HWT CS and FCI-IHT CS). Then the list of breeds that can receive FCI titles and awards; Experiences of HEC were discussed. Luigi Guidobono Cavalchini presented some information about the 2nd FCI TS HEC in 2024. The championship will be organized on 3rd-6th October 2024. in Bibbona, Tuscany, Italy. The rules of C.I.B and FCI TS HEC were also modified. The Administration of FCI Herding Events as well as the Questionary of the Herding Situation in our Countries were also on the agenda.

The commission will have an election at our next meeting which will be held in connection with the FCI TS HEC on 5th-6th October 2024.

The commission was extended with new members (Estonia and Poland). This seems to be a positive trend for the future, as the herding activity is increasing. With this comes an increased responsibility to ensure that this cynological activity must be also developed in the right direction.

There are next challenges in front of us: electing a new leadership at our meeting in Italy this year, arranging the questions around the breed lists, developing the communication and information exchange, helping the common understanding of the significance of herding and livestock guarding work, emphasizing the importance of following the rules and expecting compliance more consistently.

Finally, we must continue to refine our rules and regulations so that as many people as possible can enjoy the dog activities offered by the FCI and that the social acceptance of it must be increased.

### 04-20-2023 & 04-27-2023:

### 08-18-2023, 08-19-2023 & 08-20-2023:

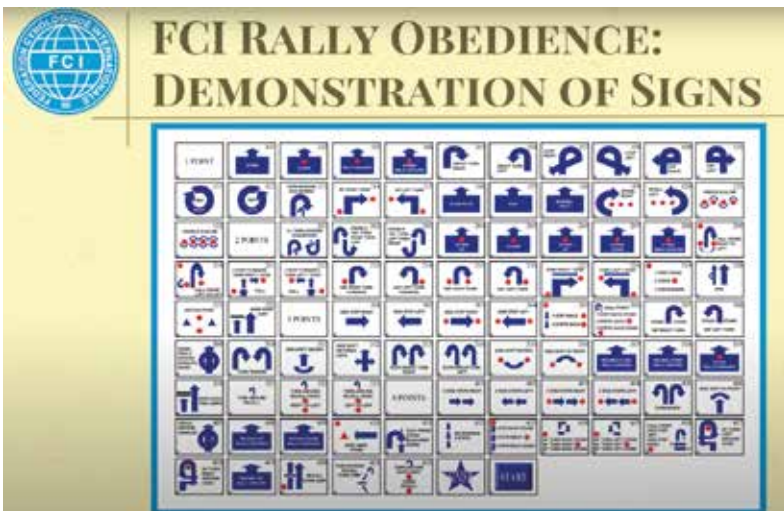
### 11-06-2023:

# FCI RESCUE DOGS COMMISSION

## ACTIVITY REPORT

The year 2023, for the FCI Rescue Dogs Commission, is a special and varied one.

Since February, several canine teams, members of national canine associations, FCI members have participated in the search for people, following the earthquake in Turkey.

More than 12 teams (over 60 rescue dogs) were involved for 14 days and had remarkable achievements, they found both living and deceased people.

The help of each team was appreciated at the highest level by the Turkish government and the Turkish embassy in each participating country, the search-rescue dogs receiving awards and special diplomas.

The media coverage of the activity and results of the rescue dogs, following the earthquake in Turkey, led to greater and varied involvement of the business environment, as sponsors and donors.

The increasingly varied and numerous participation in all rescue specialties, from as many FCI member countries as possible, in the World Championship of Rescue dogs, is a sure indicator of the development of rescue search activity, worldwide.

Today, it is no longer a surprise to see on the podium, at the FCI World Championships, countries that had no tradition in this sport, but have a major interest in the development of this specialty.

The increasing number of participants, from one year to the next, at the Judges Seminar and at rescue Trainers Seminar, is another indicator that proves that the new strategy of the FCI Rescue Dogs Commission is on an upward path.

The increase in delegations, members of the FCI Rescue Dogs Commission, shows the desire to develop this activity within the FCI, from as many countries as possible.

Today we observe a great interest from dog breeders, their dogs with great results in international dogs shows, also participate in the examinations for rescue dogs. Today, more than 40 dog breeds are involved in rescue competitions and exams.

Increasing the number of partners is another policy of the Rescue Commission, which is beginning to be seen.

The adaptation of the regulations for rescue dogs is another vision of the Commission, that all rescue dogs have a high adaptability coefficient in exams, having as a model the typology of disasters that happened in the areas of the world.

FCI's rescue dog activity is growing more and more and varied.

# FCI COMMISSION FOR SIGHTHOUND SPORT (CSS) ACTIVITY REPORT

FCI sighthound sport covers lure coursing and racing. Both are based on the instinct of a sighthound to catch fast moving prey. Lure coursing is a way to quantify sighthounds natural working capabilities, their ability to use their capacity to run fast and turn quickly to catch a prey (lure). Racing is a way to judge a sighthound 's ability to run with multiple direct competitors and to cover a distance as fast as possible. Lure coursing and racing have a large common base, but in organizing the events and participating they are significant different.

Therefore, the practical application of the common regulations in the FCI Regulations for International Sighthound Racing and Lure Coursing Events needs different approaches for both.

For lure coursing the new regulations are broadly accepted and the international calendar announced more than 50 international lure coursing events during 2023 and a FCI World Championship Lure Coursing in Sweden.

For racing, the implementation is more difficult. The CSS decided at the meeting of 2022 to compose a working group 'racing' with experts from all countries organising racing. This working group started with a thorough review of the racing regulations. In preparation of the CSS meeting in Sweden, there were a lot of meetings by the working groups racing and rulebook, frequent consultation with the national sighthound commissions and informative meetings with the CSS-delegates to keep everyone informed and to progress towards the common goal. Some of the proposals to change the racing regulations affected the general regulations and, to lesser extent the specific lure coursing regulations. With a lot of hard work, goodwill and focus on the best solution for our sport, renewed FCI regulations for international lure coursing and racing events could be presented. Subsequently, the FCI board expeditiously considered and approved these regulations so that they are valid from 1 January 2024.

All this work has immediate results: the international calendar 2024 announces again international racing events and an application for a FCI World Championship Racing 2025 has been submitted.



The working groups racing and rule-book will make an evaluation of the new international racing events. This evaluation will be submitted to CSS this and CSS will propose adjustments if necessary.

2023 also gave us a very well organised and executed CSS World Winner Lure Coursing event and FCI World Championship Lure Coursing in Kristianstad, Sweden.

The FCI Commission for Sighthound Sport (CSS) is very satisfied with the past working year and looks with even more eagerness to the future.



### FCI CHAMPIONSHIPS 2023

The CSS World Winner Event and FCI World Championship Lure Coursing 2023 was allocated to Sweden and took place in Kristianstad from June 29th till July 2nd. 809 dogs coming from 22 countries participated during 4 days on 3 fields. Every dog was judged by 6 different judges coming from 6 different countries. It was a very good championship with challenging tracks and fields designed for high quality dogs in physical good condition. Judges gave a lot of positive feedback. The event was well prepared and professionally managed. Participants, visitors, and officials had very good accommodations, felt very welcomed and supported. The Swedish organizer had a lot of working volunteers that were very kind and did a splendid job. Results are available on the FCI website.



### MEETINGS OF THE COMMISSION

The FCI Commission for Sighthound Sport has 2 major priorities:

- Allocation and supervision of the FCI World Championships and CSS World Winner events.
- Keeping the 'FCI Regulations for International Sighthound Races and Lure Coursing Events' and the 'FCI International Guidelines for Lure Coursing Judges' up to date.

There was an informative video meeting of the CSS on February 4th, 20 out of 23 delegates were present at that meeting.

Traditionally the physical meeting of our commission is held together with the FCI World Championship Coursing. This meeting was held in Kristianstad, Sweden May 25th. 18 out of 23 countries attended the meeting. Main agenda point was the approval of the adapted international regulations for lure coursing and racing events. The chapter about racing was almost completely rewritten. After a history of organising FCI championships lure coursing and racing together with friendly competitions for whippet and italian grey-

hound sprinters, the last two years FCI World Championships lure coursing and racing were held together with CSS World Winner events. From 2024 onwards, all sighthound and breeds of group 5, mentioned in our regulations, will compete on a FCI World Championship lure coursing or racing.

In 2023 there was an additional CSS video meeting according to the new FCI regulations on November 18th. 18 out of 23 delegates were present. The president Willem Vermaut (BE) and secretary Els Siebel (NL) for the commission were elected for the next 2 years. As president I am very pleased with the high number of delegates present at our commission's meetings, it shows great commitment and involvement.

The following working groups remain active to do the necessary preparatory work for the annual CSS meetings:

- Working Group Guidelines for organizers of CSS World Winner events and FCI World Championships
- Working Group International guidelines for Lure Coursing Judges
- Working Group Racing
- Working Group Rulebook

# FCI SHOWS COMMISSION

## ACTIVITY REPORT

The FCI Show commission had a really turbulent period in the last two years.

Firstly, following the decisions of the FCI, Ekaterina Domogatskaya resigned from the position of Commission Secretary.

The Annual Meeting was scheduled to take place at the beginning of February in Lima, Peru.

Due to the riots that occurred during the initial scheduled meeting of the FCI show commission, it was postponed for the end of July. The annual meeting was held on July 29th.

At said meeting Aida Rivera took over the Secretary duties until this year's election.

But very soon after, just a few months Wilfred Olsen resigned from his position.

I personally wasn't able to attend the meeting.

There were 21 delegates. The meeting was well organized with great hospitality offered by Peruvian Kennel Club and president Mrs. Ilaria Biondi de Ciabatti.

### HIGHLIGHTS OF 2023

The World Dog Show 2023 was organized in Geneva, Switzerland at the end of August. The total number of dogs entered was 13.406.



The section show in the America and the Caribbean Section 2023 was organized by the Kennel Club of Uruguay at the end of April in Punta del Este.

The total number of dogs entered was 670.



The section show in the European Section 2023 was organized by the Danish Kennel Club middle of May in Herning. The total number of dogs entered was 10.989.



The show with Title of «Winner FCI Europe Section Show 2023» for the 10 breeds banned in Danmark was held in Budapest, Hungary.

The total number of dogs entered in this 10 breeds was 386.



The section show in the Asia, Africa and Oceania section 2023 was organized by the Kennel Club of Taiwan at the end of April in Kaohsiung. The total number of dogs entered was 1.424



The World Dog Show in 2024 had to be cancelled due to the war in Ukraine.

The General Committee of the FCI entrusted the hosting of the World Dog Show to the Croatian Kennel Club. The exhibition will be held on the originally scheduled date of April 25-28, 2024. in Zagreb. Statistic of 2023

A total of 1075 CACIB were entered on the FCI list of the International shows. The number of the CACIB dog shows was lower than before caused by situation in Russia, Ukraine and Bulgaria.

The number is distributed on the sections : Europe 748 CACIB, The Americas & Caribbean 179 CACIB shows and Asia, Africa & Oceania 147 CACIB shows.

More than a year has passed since the introduction of new titles for international junior and veteran beauty champions. We have made a short analysis of the confirmed titles during the Year 2023.

In 2023, 2425 international junior champion titles were confirmed by the FCI. The number of confirmed international veteran champion titles is 815.

Comparing confirmed international junior champion titles with the titles of International beauty champion in Year 2023 it is as much as 42%.

FCI member countries for which FCI confirmed the most International junior

champion titles are : Finland, (364), Czech Republic (248), Germany (208), while for the title international veteran champion are : Finland (235), Germany (80), Sweden (74).

Analysis shows that the introduction of these international titles has been extremely well received by FCI members.

It should be noted that the above titles are widespread primarily in the members of the European section, while in members outside Europe they are found in smaller numbers with the exception of Japan.

Considering the mentioned numbers, this caused additional tasks for the FCI office, and it is up to the General Committee to determine how to cover them.

I would like to thank my colleagues in the Show Commission, Mr. Wilfred Olsen for his work as President and once more to Mrs. Aida Rivera Franco who is taking over the Secretary job. Also I would like to thank the members of the FCI Show judges commission for great cooperation . My thanks also go to the FCI office, to Mr. Yves De Clercq who helped me a lot, and at the end to our representative from the FCI General Committee, Ms. Barbara Müller.

I'm looking forward to the future successful cooperation with new elected FCI Show commission Vice President, Mrs. Macarena Pantaleon from Chile and Secretary Mr. Ozan Belkis from Turkey.

# FCI UTILITY DOGS COMMISSION

## ACTIVITY REPORT

In the last year, two meetings of the Working Dog Commission took place. The first meeting took place on 11 and 12 March 2023 in Sempeter, Slovenia. In this meeting, the delegates dealt in detail with the international development of Utility dogs sports and how this one, as well as large events, can be made more attractive.

A temporary report on the progress of the planned changes to the examination regulations was given.

The character assessment of the dogs was discussed intensively. Unanimously a much higher priority opinion must be given, in addition to breeding of healthy dogs. When passing the companion dog trials with a traffic and behavioral part, limitations in character assessment can

be observed with many dogs. This refers specifically to utility dog breeds, but also to other breeds. In addition to aggressive behaviour, shyness is also often observed. It was pointed out that the judges in the individual national organisations must be made aware of a correct assessment, since in addition to healthy dogs, dogs with strong temperament are the breeding goal of the FCI.

The second meeting this year took place on 11 September 2023 following the World Championships for Utility Dogs, also in Sempeter in Slovenia. In addition to the discussion of general topics, changes to the specifications were discussed.

A World Championship for tracking dogs was held in Lahti-Nastola, Finland from 15

to 20 May. This World Championship was excellently organised. A total of 39 participants from 18 nations were present.

The World Championship for Utility Dogs was held in Nova Gorica, Slovenia, from 5 September to 10 September. With 172 teams participating, a record was reached. The event was excellently organised and new standards were set.

Unfortunately, the trials statistics from the individual members are not complete. The trials included are also listed in the International Utility Dog trials of the FCI. The figures submitted show the following picture:

## AUDIT REPORT

### To the members of the Fédération Cynologique Internationale

In accordance with our engagement letter dated November 29, 2018, which set up scheduled audit of the accounts of your association, we submit the report of our mission.

The managing body is responsible for establishing financial statements, which provide an accurate image - according to the Belgian accounting regulations - as well as for organising the internal control which it considers necessary to issue financial statements exempt of material misstatements. It is our responsibility to express an opinion about these financial statements, based on our audit.

We audited the association's accounts for the fiscal year ending on 31/12/2023. This audit, drawn up based on the fundamental accounting principles issued by the Institut des Experts-Comptables & Conseils Fiscaux (ITAA), includes all the samplings and checking procedures we considered appropriate in view of the circumstances. These professional standards request our inspection to be organised and carried out under the form of a review allowing to achieve reasonable assurance that the accounts do not include any significant inaccuracies on the basis of the Belgian legal and regulatory dispositions on the subject. On this framework, we collected evidence regarding the information and the amounts provided in the financial statements which we consider sufficient and appropriate to base our opinion. In addition, the persons in charge within your association, and especially the accountancy department, provided us with all the necessary explanations and documents, making our mission easy to complete.

Here are our conclusions:

In the framework of our examination, we could state that:

- The administrative organisation and the internal control are suitable for the size and scope of the association's activities.
- Without prejudice to certain formal aspects of minor importance, the accountancy is in compliance with the Belgian legal and regulatory dispositions regarding the non-profit organisations, international non-profit organisations and foundations.

In addition, neither did we detect, nor were we made aware of any operation concluded or decisions made in breach of the correspondent statutes or legislation.

We were not made aware of any event occurring after our controls, which would be likely to significantly impact the accounts and thus modify the present conclusions.

At the conclusion of our audit of the accounts, and in compliance with the above-mentioned standards, we acquired reasonable assurance that the accounting report ending on December 31st, 2023, whose total balance amounts to **5 371 232,50€** and whose income statement ends in a benefit of **124 601,75€**, provides an accurate image of the assets, of the financial situation and of the association's result, according to the Belgian legal accountancy framework.

This report cannot be used for any other purpose and its distribution is limited to the purpose described in the above-mentioned engagement letter.

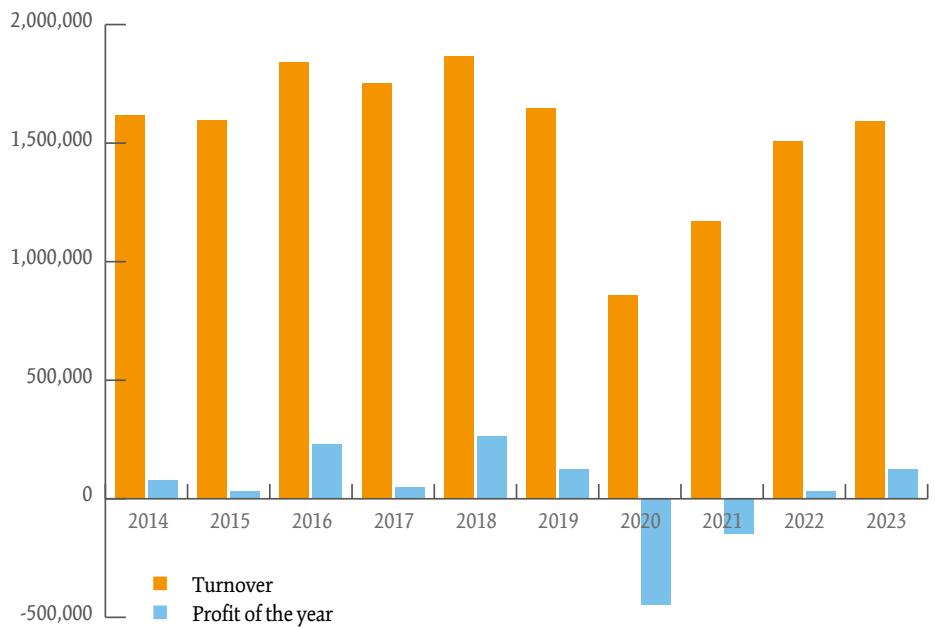

### Letter of Understanding between FCI and AKC

WHEREAS the Fédération Cynologique Internationale (FCI) and The American Kennel Club (AKC) share the common goals of promoting and protecting purebred dogs ; and

WHEREAS the parties hereto have in the past cooperated to a certain extent in carrying out this object and have been acting pursuant to certain informal agreements made from time to time for that purpose ; and

WHEREAS it is agreed that the relations between AKC and FCI and its member registries should be explicitly written with a view towards future cooperation ;

NOW, this letter of understanding encompasses the mutually agreed to basis for the relationship between the parties as follows :

1. AKC will recognize the pedigree for any FCI registry that meets AKC requirements and that wishes to have such recognition.
2. AKC will not automatically give exclusive recognition to the FCI registry in any country in which there are multiple registries and FCI will not automatically give exclusive recognition to AKC's registry in the United States.
3. AKC will not register any dog born in an FCI member country until that dog has been registered in the Stud Book of the FCI registry or the AKC-recognised registry in that country. No dog born in the USA, belonging to breeds recognised by the AKC, will be registered by an FCI member registry unless the dog has been registered in the FCI-recognised registry in the United States. It is up to the FCI to decide about the registration of dogs born in the USA belonging to breeds not recognised by the AKC.
4. Each of the parties agree that when any information comes to its knowledge which might reasonably affect or be useful to the other party (AKC judges suspension, amended standards, etc.), it will immediately communicate such information to the other party.
5. FCI and AKC will deal with the judging approval reciprocity in a separate document (see attachment).

6. AKC will not sponsor any event in the country of an FCI member without the express permission of FCI and the FCI member. FCI will not sponsor any event within the territory of the United States without the express permission of AKC. Puerto Rico is exempted from this provision as both AKC and FCI have been previously sponsoring activities on that island.
7. While not an FCI member, FCI has graciously agreed to permit AKC to participate in its World or Section Agility, Utility, Obedience, etc. Championship Event provided that this participation does not prevent representative teams of FCI member organisations from taking part. If the AKC teams win the competition, they are not eligible for the title of FCI Winner at these events.
8. AKC registered dogs are eligible for the title of FCI International Champion under specific conditions to be agreed upon by the AKC and FCI.
9. Except with the agreement of the AKC, the FCI will not register kennel names for breeders living in USA (with exception of Puerto Rico) and, except with the agreement of the FCI, the AKC will not register kennel names for breeders living in countries where the FCI has a member, which the AKC has accepted.
10. FCI agrees to send to the AKC headquarters all revised breed standards and AKC agrees to send to the FCI headquarters copies of its Complete Dog Book, which includes all AKC standards, each time that such publication is revised.
11. The terms of this letter of understanding is agreed to by the parties listed below. This agreement may be terminated by either party upon reasonable notification to the other party.

### Breed Judging

At FCI CACIB international shows, the AKC judges are eligible to judge and award the CACIB provided that the two following conditions are fulfilled:

1. the breeds they are scheduled to judge are recognised by the AKC (this does not include FSS and Miscellaneous classes).
2. the judges in question are allowed to judge, under AKC regulations, the breeds in question at AKC events and award them championship points. An AKC judge, residing in the United States, may not be approved as an FCI judge (breed, group, all breed) eligible to award CACIB.

At AKC events, the FCI judges are eligible to judge and award championship points provided that the following conditions are fulfilled:

1. the breeds they are scheduled to judge are recognised by the FCI and by the national kennel club, in their country of residence, which has jurisdiction over the judges in question
2. the judges are members of their national kennel club, in their country of residence, which is an FCI member or contract partner
3. the judges in question are allowed to judge, under FCI regulations, the breeds in question at FCI International CACIB shows and award them the CACIB

### Group and BIS Judging

It is up to both, the AKC and the FCI members, to choose to invite or not a judge to judge a particular group (according to FCI or AKC breed nomenclature) at an AKC event or at an international FCI CACIB show taking into consideration the experience of the judge, his judging credentials and the breeds and their numbers in the groups to judge.

## Letter of Understanding between the Fédération Cynologique Internationale and the Kennel Club

WHEREAS the Fédération Cynologique Internationale (FCI) and the Kennel Club (KC) share the common goals of promoting and protecting, in the case of the FCI, pedigree dogs and in the case of the Kennel Club, all dogs; and

WHEREAS the parties hereto have in the past cooperated to a certain extent in carrying out this object and have been acting pursuant to certain informal agreements made from time to time for that purpose; and

WHEREAS it is agreed that the relations between KC and FCI and its member registries should be explicitly written with a view towards future cooperation;

NOW, this letter of understanding encompasses the mutually agreed basis for the relationship between the parties as follows:

1. The KC, where it recognises the breed in question, will recognise the pedigree of any FCI registry that meets KC requirements and that wishes to have such recognition.
2. In so far as it is lawful, the KC will give exclusive recognition to the FCI registry in any country in which there are multiple registries provided that these registries meet KC requirements and the FCI will give exclusive recognition to the KC's registry in the United Kingdom. For the time being this will not include Malta and China.
3. The KC will not register any dog, or issue a pedigree to any dog, born in an FCI member country whose registry the KC recognises, until that dog has been registered in the FCI registry in that country. No dog born in the UK will be registered, or have a pedigree issued, by an FCI member registry unless the dog has been registered by the KC in the United Kingdom.
4. Each of the parties agree that when any information comes to its knowledge which might reasonably affect or be useful to the other party (KC or FCI judges suspension, amended standards, etc.), it will immediately communicate such information to the other party.
5. The FCI and the KC will endeavour to agree on the conditions to make their respective judges eligible to officiate at events sanctioned by them (FCI and KC).
6. The KC will not sponsor or support any event for dogs in the country of a current FCI member without the express permission of the FCI member. The FCI will not sponsor or support any event for dogs within the territory of the United Kingdom without the express permission of the KC. For the time being this will not include Malta and China.



7. While the KC is not an FCI member, the FCI has graciously agreed to permit the KC to participate in its World or Section Agility, Utility, Obedience, etc. Championship Event provided that this participation does not prevent representative teams of FCI member organisations from taking part. The KC teams may win the competition but are not eligible for the title of FCI Winner at these events.
8. The FCI agrees to send to the KC headquarters all revised breed standards and the KC agrees to send to the FCI headquarters copies of all revised breed standards. The FCI and KC will discuss health issues connected with breed standards on a regular basis.
9. FCI members are allowed to refer to the title of UK Champion by using the abbreviation "UK Ch + name of the dog".
10. Except with the agreement of the KC, the FCI will not register kennel names of breeders living in the UK and, except with the agreement of the FCI, the KC will not register kennel names of breeders living in countries where the FCI has a member, which the KC has accepted.
11. The terms of this letter of understanding are agreed to by the parties listed below. This agreement may be terminated by either party upon reasonable notification to the other party.

## AGREEMENT ON THE MUTUAL RECOGNITION OF DOG SHOW JUDGES BETWEEN THE KENNEL CLUB AND THE FEDERATION CYNOLOGIQUE INTERNATIONALE

*This agreement refers only to the mutual recognition of judges, hereinafter referred to as 'FCI Judges' who are resident in a FCI member country and are listed as designated 'International Judges' in the 'Judges Directory published by the Fédération Cynologique Internationale (FCI), to award Challenge Certificates and to judge Groups and Best in Show at Kennel Club (KC) licensed Championship Shows and for UK resident judges who are approved to award Challenge Certificates and Groups and Best in Show as published on the Kennel Club's Find a Judge<sup>2</sup> website to award Certificats d'Aptitude au Championnat International de Beauté (CACIBs) and to judge Groups and Best in Show at International FCI CACIB Shows held under the auspices of the Fédération Cynologique Internationale (FCI).*

***It is intended that this agreement exists to recognise the mutual respect of both FCI and Kennel Club for judges and their training and education while upholding the highest standards of judging.***

*Furthermore, all other recognised canine activities such as Competitive Obedience, Agility, Field Trials, Working Trials etc. are specifically excluded.*

1. This agreement will commence on the 1st day of May in 2022 and will be binding on both parties, subject to the right of termination by one or other of the parties giving no less than six months' notice prior to such termination.
2. Subject to six months' notice this agreement may be amended at any time by mutual agreement of the parties concerned.
3. **This agreement is predicated on the basis that the Kennel Club (KC) and Fédération Cynologique Internationale (FCI) have agreed to recognise and respect the knowledge and experience of their approved judges of their respective schemes for the approval, education and training of dog show judges.**

### **Approval to award Kennel Club Challenge Certificates (CCs)**

4. The Kennel Club will accept nominations for approval, in accordance with Kennel Club Rules and Regulations and appropriate Codes of Best Practice as published and amended from time to time, to award Challenge Certificates to a breed(s) for the first time, without requesting completion of a Kennel Club Questionnaire, for FCI Judges resident in an FCI member country, providing they are suitably experienced, having previously awarded CACIBs to the relevant breed(s) in at least three different countries for a minimum period of 5 years prior to their first UK appointment for the breed(s).

5. FCI Judges resident in an FCI member country who were previously approved to award Challenge Certificates at Kennel Club licensed Championship Shows prior to the signing of this agreement will continue to be considered for approval for subsequent appointments subject to the proviso that they remain in good standing.
6. All nominations to judge at KC licensed shows will continue to be subject to the approval of the Kennel Club's Board.

**Approval to award Fédération Cynologique Internationale Certificat d'Aptitude au Championnat International de Beauté (CACIBs)**

7. UK resident judges who remain in good standing and are listed as having been approved to award Challenge Certificates for the relevant breeds on the Kennel Club Find a Judge website will be eligible to award CACIBs to these breeds.

**Approval to judge Groups at International FCI CACIB Shows and Kennel Club licensed Championship Shows**

8. FCI Judges resident in an FCI member country who were previously approved to judge Groups at Kennel Club licensed Championship Shows prior to the signing of this agreement will continue to be considered for subsequent appointments subject to the proviso that they remain in good standing.
9. UK resident judges who were previously approved to judge Groups at International FCI CACIB Shows, prior to the signing of this agreement will continue to be recognised as approved to judge the relevant Group(s) subject to the proviso that they remain in good standing.
10. The FCI and KC recognise and respect each other's approval criteria and agree to the mutual recognition of all those approved to judge Groups at International FCI CACIB Shows and at KC licensed Championship Shows. Those judges listed on the FCI Judges Directory and KC Find a Judge are eligible to accept an invitation to judge at this level, subject to the approval of the national kennel club.

**Approval to judge Best in Show at International FCI CACIB Shows and Kennel Club licensed Championship Shows**

The FCI and KC recognise each other's approval criteria and agree to the mutual recognition of all those approved to judge Best in Show at International FCI CACIB Shows and at KC licensed Championship Shows. Those judges listed on the FCI Judges Directory and KC Find a Judge are eligible to accept an invitation to judge at this level, subject to the approval of the national kennel club.

### **Memorandum of Understanding between FCI and CKC**

WHEREAS the Fédération Cynologique Internationale (FCI) and The Canadian Kennel Club (CKC) share the common goals of promoting and protecting purebred dogs;

WHEREAS the CKC and the FCI have, in the past, cooperated to a certain extent in carrying out these goals and have been acting pursuant to certain informal agreements made from time to time for that purpose;

WHEREAS it is recognized that both the FCI and the CKC are required to operate within the limits of the legislation governing their activities, including their respective constitution and by-laws;

NOW this letter of understanding expresses a mutually agreed to basis for the relationship between the CKC and the FCI as follows:

1. The CKC acknowledges the role of the FCI and its governing institutions as set out in the FCI Statutes as the primary world federation of dog registries.
2. The FCI acknowledges the CKC as the primary kennel club in Canada.
3. The CKC and the FCI agree that when any information comes to the knowledge of one party, which might reasonably affect or be useful to the other party (judges suspension, amended standards etc.), it will immediately communicate, in writing, such information to the other party.
4. The parties will meet at the request of either of them, within a reasonable timeframe and on basis of a consistent mutually agreed agenda which will include matters of common interest.

5. The FCI agrees to send to the CKC head office a copy of all breed standards with revisions as they occur and CKC agrees to send to the FCI headquarters all CKC breed standards with revision as they occur. The FCI and CKC will also share information concerning the decisions of their respective governing bodies such as the exchange of official publications.
6. The CKC will periodically provide the FCI with a list of the registries from the FCI member countries with which the CKC has reached an agreement providing for the mutual recognition of studbooks and pedigrees. The CKC will get in touch with all the FCI members and contract partners and inform them about the procedure to follow to gain CKC recognition. The FCI will notify the CKC of the accession of any country to FCI membership.
7. The details of a mutual recognition of FCI and CKC judges are written on a document which is part of this contract.
8. The FCI will not sponsor or sanction any event within Canada without the express permission of the CKC.
9. The CKC will not sponsor or sanction any event in an FCI member country without the express permission of the FCI and the agreement of the member country.
10. While not an FCI member, FCI graciously agrees to permit CKC to participate in its World or Section Agility, Utility, and Obedience Championship Events and any forthcoming canine performance event that may be mutually recognized by both organizations.
11. As long as no agreement is reached with regard to the working breeds (according to the FCI nomenclature) between the FCI and CKC, these breeds (CKC-registered dogs) are not eligible for the title of "International Beauty Champion". The non-working breeds (CKC-registered dogs) are eligible for this title provided that they comply with the FCI International Championship Regulations, i.e. 4 CACIB in 3 countries under 3 different FCI judges.
12. The CKC registered dogs are eligible for the other FCI international titles provided that they meet with the FCI requirements.
13. The FCI international directory of kennel names (affixes) is not open to CKC breeders and the FCI cannot guarantee that a CKC kennel name (affix) will not be similar to an FCI registered kennel name (affix) and conversely.

14. Both parties agree that the present Letter of Understanding shall not be interpreted or applied so as to require either party to act in a manner not authorized by or contrary to applicable legislation, including each party's constitution, rules or by-laws.
15. The terms of this Letter of Understanding are agreed to by both parties. This agreement may be terminated by either party upon giving the other party 60 days notice in writing.

### **CKC Judges eligibility to officiate at FCI International Events**

From April 1<sup>st</sup>, 2009, the following dispositions will apply:

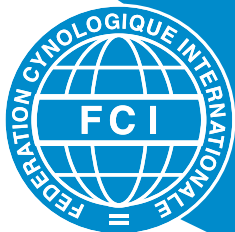
- a) CKC judges are allowed to judge in the FCI member countries all-breed, group and specialty national shows, the breeds they are approved to judge in Canada.
- b) CKC judges who have already judged international FCI CACIB shows before December 31<sup>st</sup>, 2007, are allowed to award CACIB at international FCI CACIB shows, FCI World and Sections shows, to the breeds they are approved to judge in Canada.
- c) Once a CKC judge has judged four (4) national shows in four (4) different FCI member countries by the FCI breed standards, he/she is allowed to award CACIB to the breeds he/she is approved to judge in Canada.

It will be the responsibility of the FCI Office and of the judges concerned to keep track of assignments undertaken in an FCI member country. Taking into account the legal restrictions on the exercise of extra-territorial jurisdiction by the CKC, it will be the responsibility of the CKC to communicate them to their judges and the practical implementation and enforcement of the agreed above principles will be under the responsibility of the FCI Office, of the FCI members and the judges concerned.
